San Francisco Department of Technology

SB 716 (Durazo): Lifeline program: broadband internet access service.

Recommended Position: Support

The Department of Technology (DT) recommends a SUPPORT position on SB 716 as currently drafted (7/17/25), which would add stand-alone broadband Internet service to the California LifeLine program. This would enable low-income households to receive a monthly subsidy of up to \$30/month for qualifying home Internet service (at least 100/20 Mbps). Participating ISPs would be eligible for up to \$19/month/subscriber in funding from the California Lifeline program and \$9.25/month/subscriber from the federal component of the program. SB 716 also removes the historic barrier that ISPs receive "Eligible Telecommunications Carrier" (ETC) certification from the CPUC, reducing a major regulatory barrier to participation from local governments and other entities. SB 716 would authorize the CPUC to implement the program, which would sunset in 2032.

SB 283 (Laird): Energy Storage Systems. *Recommended Position: Support*

The bill would conform the California Building Code (CBC) and safety certification requirements to the National Fire Protection Association (NFPA) 855 standards for battery storage. Specifically, the bill would require projects submitted for certification to the California Energy Commission (CEC) to demonstrate that they are constructed consistent with the CBC or NFPA 855, whichever is most protective. SB 283 would require projects submitted to local authorities to be designed in accordance with NFPA 855. The bill would also require projects submitted to the CEC or local authorities to be inspected by local fire officials prior to commencing operations.

The SFPUC recommends a support position for SB 283.

SB 63 (Wiener): San Francisco Bay Area Local revenue measure: transportation

funding

SB 63 would establish a Transportation Revenue Measure District including Alameda, Contra Costa and San Francisco counties, with a provision for San Mateo and Santa Clara counties to opt in, to be administered by the Metropolitan

Transportation Commission (MTC). The bill would authorize a multi-county regional transportation funding measure in the form of a sales tax, for a duration of 10 to 15 years subject to voter approval on the November 2026 ballot, to fund transit operations in the Bay Area.

SB 694 (Archuleta): Deceptive Practices: Service Members and Veterans

Background/Analysis

In 2020 in response to the COVID pandemic, the federal Affordable Connectivity Program (ACP) was created to offer eligible households a \$30/month broadband discount through participating ISPs, with broad provider participation and plan designs that zeroed out customer bills. At its peak, ACP supported about 3 million California households. However, ACP ran out of funding and ended in 2024. SB 716 aims to fill part of that affordability gap by adding a state-level, ACP-like option within the existing California LifeLine program.

San Francisco's Fiber-to-Housing (FTH) program already provide free broadband service to non profit-managed affordable housing sites containing over 20,000 households. DT maintains the

network and MOHCD provides customer support. Under SB 716's framework, DT (or an affiliate) could qualify to receive the state LifeLine broadband subsidy for eligible FTH households once CPUC rules are adopted. This could create a significant new funding stream for maintaining and growing the FTH program. There is a significant backlog of affordable housing sites that have not been connected to the FTH network. SB 716 could also allow for the potential expansion of the program to eligible low-income households that do not live in affordable housing.

Challenge

Affordability is the top barrier to home broadband adoption for low-income households—even where infrastructure exists. State survey data show cost far outpaces other reasons for non-subscription. LifeLine is currently a phone-centric benefit, and there is no statewide option to apply the benefit to standalone home broadband, which residents need for school, work, telehealth, and more.

Solution/Recommended Proposal

SB 716 would provide direct affordability relief for tens of thousands of low-income San Francisco households by allowing the LifeLine subsidy to be applied to a home broadband plan. If DT was able to qualify as a participating ISP, this could generate more than \$1 million in annual revenue to fund the City's digital-equity programs.

Departments Impacted & Why

- DT: Potential new funding stream for maintaining and growing the FTH network.
- MOHCD: Potential new funding stream for FTH customer service.

Fiscal Impact

If DT was eligible for the SB 716 subsidy, and 25% of the 20,000 FTH households were enrolled, it would generate \$1.1 million in annual revenue, or \$1.7 million if DT was able to obtain ETC certification.
