New Business

San Francisco Ethics Commission

Presenter: Michael Canning

AB 775 (Fong): Behested payments: reporting.

Recommended Position: Support

This bill would require the State's behested payment disclosure reports to be filed electronically with the Fair Political Practices Commission (FPPC), unless the appropriate local government agency is willing to accept the forms and post them online. The bill also modifies the deadlines for elected officials reporting behested payments.

Ethics Commission staff recommend the City support this legislation as it will improve the processes associated with the filing of a required State form and demonstrate a flexible model for the filing of State forms with local governments that may be beneficial for other filings in the future.

San Francisco Public Utilities Commission

SB 72 (Caballero): California Water Plan: long-term supply targets.

Recommended Position: Support

SB 72 revises the California Water Plan to expand upon and plan for long-term water supply targets to overcome a drought. Future plans must include various scenarios for water supply targets with a 50-year planning horizon. For the 2028 plan, the bill solidifies a planning target of 9,000,000 acre-feet of additional water or storage capacity.

The bill also requires the Department of Water Resources (Department) to identify California's water needs across regions and impacts associated with proposed projects. In order to evaluate best practices for preservation of natural resources and stewardship of the land, the Department will confer with an advisory committee. The committee will be comprised of a wide range of stakeholders including representation from unions, tribes, local governments, water agencies, and expert researchers on the environment, water, and climate science.

The SFPUC recommends a support position for SB 72.

San Francisco Adult Probation Department

AB 247 (Bryan): Incarcerated individual hand crew members: wages **Recommended Position: Support**

AB 247 requires incarcerated hand crew members and a ward or youth placed at the Pine Grove Youth Conservation Camp to be paid an hourly wage of \$7.25 and to have the wage rate updated on an annual basis.

San Francisco Adult Probation Department

AB 248 (Bryan): Uncapped Earnings for Incarcerated Workers Act

Recommended Position: Support

Authorizes the County Board of Supervisors to determine a wage to be credited to each prisoner if the prisoner is confined in or committed to a county jail and performs a work assignment.

San Francisco Adult Probation Department

AB 1140 (Connolly): Single-Occupancy Cell Pilot Program.

Recommended Position: Support

AB 1140 will implement a pilot program in four adult facilities, requiring that 10% or more of the incarcerated population in those facilities be housed in single-occupancy cells.

San Francisco Department of Early Childhood

AB 753 (Garcia): Childcare: facility licensure: teacher requirements.

Recommended Position: Support

California continues to experience ongoing early childhood educator staffing shortages. These shortages impact families in accessing care and the stability it provides. Providers struggle to keep classrooms fully staffed. AB 753 addresses staffing shortages while providing a workforce pathway which eliminates barriers for early in their career as educators.

San Francisco Environment Department

SB 615 (Allen): Vehicle traction batteries. *Recommended Position: Support*

SB 615 would create a framework to ensure all electric vehicle (EV) batteries are eventually recycled at their end of life and encourages sustainable practices of repair and repurposing. San Francisco is committed to achieving net-zero

greenhouse gas emissions by 2040, as outlined in our Climate Action Plan, which prioritizes electrifying transportation and building a regenerative circular economy that minimizes waste production. As more residents and fleets transition to EVs, we must ensure that the growing volume of EV batteries is handled in a way that protects public health, conserves resources, and reduces environmental harm. Research published by the Department of Energy shows the potential of recycled EV batteries, which could continue to be used for energy storage applications and work for 10 years or more after end of life, barring failure or damages.
