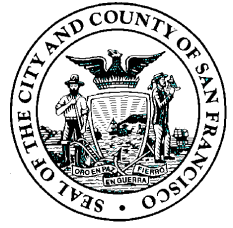

**2) APPROVAL OF THE MINUTES OF THE HEALTH COMMISSION MEETING OF DECEMBER 15, 2025.**

#### 4) **DIRECTOR'S REPORT**

Daniel Tsai, DPH Director of Health, presented the item.

##### **INFLUENZA AWARENESS**

Influenza (flu) activity has been increasing in San Francisco in recent weeks. Before the holidays, the Population Health Division and DPH Communications conducted interviews with print, radio, and television media to encourage flu vaccination and promote other steps to stay healthy.

DPH is encouraging people to take the following steps to keep themselves and the community healthy this winter:

- Everyone six months and over should get the latest flu vaccine as soon as they can. While the vaccine does not always prevent infection, it is effective against severe illness and hospitalization. The flu vaccine can also be given at the same time as the COVID vaccine, which is also strongly recommended. Visit [sf.gov/vax](http://sf.gov/vax) for more information.
- If you are in a crowded indoor space such as a train or a plane, wear a well-fitted, high-quality mask like a KN95.
- Wash your hands regularly and cover your cough or sneeze with a tissue or your elbow.
- If you have symptoms of flu, such as a fever, cough, sore throat, or body aches, avoid contact with people by staying home. People with flu are most contagious during the first 3 days of their illness. If you are sick, especially if you are at [higher risk of severe illness](#), you should promptly contact your health care provider to be tested and get treatment.

##### **DISEASE CONTROL AND CONTACT TRACING IN SHELTER HEALTH**

A quick-thinking Shelter Health Nurse identified a guest with potentially serious health issues and sent him to the Emergency Department the Wednesday before Thanksgiving. The patient was diagnosed with bacterial meningitis, a contagious and potentially deadly disease. WPIC Shelter Health, the Department of Homelessness and Supportive Housing, Urban Alchemy, and Communicable Diseases pulled staff together to create a plan that included prescribing and dispensing prophylaxis to close contacts, disseminating information around bacterial meningitis to onsite staff for their information and to post on site, and planning for close contact follow-ups over the Thanksgiving holiday.

This was a quick collaborative effort in disease control and prevention, a core public health tenet. Special thanks to the Shelter Health team who completed contract tracing and provided post-exposure prophylaxis to close contacts within three hours of the initial report.

##### **COVID-19 UPDATE**

As of 12/30/20:

- San Francisco's 7-day rolling average of COVID test positivity is 0.9%.
- Twenty-one percent of SF residents are fully up to date on their COVID vaccinations and have received the updated vaccine.

##### **Public Comment:**

Commissioner Comments:

Commissioner Giraudo asked if CDPH will be putting out guidelines for California since the recent Center for Disease Control vaccine schedule eliminates some vaccines. Director Tsai stated that it is so important for parents to continue vaccine their children. He added that California passed legislation last year that requires insurers to pay for vaccines on the existing list of required vaccines.

Commissioner Giraudo noted that she is concerned that Medi-Cal participants understand that vaccines are still available and covered by Medi-Cal. Director Tsai agreed that messaging around this issue is very important.

Commissioner Christian stated that she hopes that decision makers keep in mind the need for effective and substantial behavioral health. She added that if justice-involved mental health services are reduced due to budget issues, it impacts the safety of the community.

President Green requested that Director Tsai and DPH staff update the Health Commission as more details regarding health disparities that will be prioritized by the DPH and community.

5) **RESOLUTION TO RETROACTIVELY AUTHORIZE THE DEPARTMENT OF PUBLIC HEALTH TO ACCEPT AND EXPEND A GIFT OF \$480,000 FROM BREAKING THE CYCLE THROUGH THE HOMES FOR THE HOMELESS FUND LLC, A SUBSIDIARY OF THE HOUSING ACCELERATOR FUND**

Todd Barrett, San Francisco Health Network Chief Medical Officer, presented the item.

6) **BEHAVIORAL HEALTH SERVICES UPDATE**

Hillary Kunins, MD, MPH, MS Director, Behavioral Health Services and Mental Health SF, presented the item.

Regarding slide 11, Commissioner Giraudo asked for an estimated timeline of when this initiative will begin increasing care delivery. Dr. Kunins stated that the planning for this initiative is happening now. The Health Commission will be updated when the timeline is developed.

Commissioner Giraudo asked if there is data from community-based organizations regarding individuals who refuse services. Dr. Kunins stated that this data is not universally collected, and she feels it's important to get feedback to improve the system.

Commissioner Christian requested that the information on client refusal of services be presented to the Health Commission annually to inform them of gaps in the system. Dr. Kunins stated that currently focus groups, needs assessments, and frontline staff interviews have been used to gather this data. She will take this request to the BHS team and will report back to the Commission.

President Green asked if the state is developing best practices as part of the new Behavioral Health Services Act (BHSA). Dr. Kunins stated that part of BHSA reform is insistence on using evidence-based practices.

**7) DPH BUDGET FY2026-27 and FY2027-28**

Drew Murrell, DPH Chief Financial Officer, presented the item.

The lawsuit was filed on September 23, 2024, in San Francisco Superior Court, Case No. CGC-24-618348. The lawsuit involves an employment dispute, with the City to pay \$52,000.
