**Subject:** Resolution Approving the Appointment of Officers to the Housing, Infrastructure, Transportation and Sustainability Committee to Serve a Twelve (12) month Term of Office Commencing January 1, 2026 and ending December 31, 2026

**BACKGROUND AND DISCUSSION**

The Treasure Island Development Authority (“TIDA”) Bylaws authorize the Treasure Island Development Authority Board of Directors (“Board”) to create one or more committees consisting of two or more Directors to serve at the pleasure of the Board.

At its October 11, 2023, meeting, the Board established the Housing, Infrastructure, Transportation, and Sustainability (“HITS”) Committee to provide a forum for review and policy input related to housing, infrastructure, transportation, and sustainability matters. The Board wishes to continue convening the HITS Committee through 2026.

Committees may be formed at any time by a resolution of the Board, and appointments to committees are made by a majority vote of the Directors then in office.

The Directors who are interested in serving as an officer of the HITS Committee are requested to submit their names to the Commission Secretary, who will forward their name to the Board President for consideration.
