# TI Advisor Board Review

January 2026

AR/WS and InterEthnica began serving as TI Advisors in 2017. TI Advisors worked with Director Beck and his team to bring the Transition Housing Rules and Regulations (THRRs) to life and helped to create implementing policies and procedures while implementing a community engagement campaign to help residents understand their future housing options on Treasure Island and Yerba Buena Island. Housing options for Legacy Households include:

- Transition Housing
- Moving Payments
- Payments In Lieu of Transition Units or Downpayment Assistance
- Early In Lieu Payments
- Treasure Island Resident (TIR) Preference for Affordable Housing
- Premarketing Notices

In late 2019, under the direction of the TIDA Board of Directors, the program grew to include housing opportunities to Vested Residents that include Treasure Island Resident (TIR) Preference for affordable housing on Yerba Buena and Treasure Island and Premarketing Notices.

## Resident Moves Since 2017

- 24 Legacy Households moved to Transition Units at Star View Court. Thirteen of these households were early volunteers for the Transition Units.
- 3 Legacy and Vested Residents purchased Below Market Rate condominiums at The Bristol on YBI. Legacy households received Downpayment Assistance to support their purchase.
- 20 Legacy and Vested Residents used their Treasure Island Resident (TIR) Preference to move to affordable apartments on Treasure Island at Star View Court, Isle House, and Hawkins.
- 45 Legacy Households or portions of those households received In Lieu Payments and moved to affordable housing on the island or have moved from the island.

## 2026 Community Engagement

TI Advisors continue to provide support to the Director and TIDA as it implements the Transition Housing Rules and Regulations (THRRs) to offer Transition Units and other future housing opportunities. TI Advisor focus includes:

- Preparing new Preliminary Notices of Eligibility to all Legacy and Vested Households in January 2026
- Continuing to work with Legacy Households who request MOUs for In Lieu Payments
- Supporting TIDA's offering of Transition Units at Star View Court to complete the lease of 5 Transition Units and support households as they consider their future housing options.
- Supporting residents seeking to purchase Below Market Rate Inclusionary Housing at The Bristol and 490.
- Supporting TIDA's efforts to engage residents interested in new senior housing in 2028.
- Serving as a resource to TIDA and residents of The Villages to understand future housing options on Treasure Island.
- Informing policy and program implementation to support the THRRs.
- Supporting residents in the appeal process under the THRRs.
- Providing translation and interpretation services to successfully communicate with residents of The Villages.
- Supporting engagement with residents through electronic and physical outreach and resident portal tools.
- Creating engagement materials to inform residents of future housing opportunities.



## **One Treasure Island Program Report**

### **Food Pantry:**

The last pantry of 2025 served over 250 households. Residents received supplemental food including either a turkey or ham, toilet paper, laundry detergent and served hot coco during the pantry experience. Residents were very grateful, and the pantry atmosphere was festive and bright.

### **One Treasure Island Programming:**

We are currently recruiting for CTP 22, and there are 20 candidates participating in pre-selection activities.

### **Outreach & Social Media**

Outreach and social media activities resumed in January. We currently have over 1,375 TI and SF residents subscribed to the mass texting platform.

### **Community Engagement & Events**

- **Health and Wellness Hub Survey:** One TI is distributing a survey to the TI Community about helping us learn what services the TI community would like to see offered at the health and wellness hub! Anyone who takes the survey is entered to win a \$50 gift card as an incentive.
- One TI is seeking members of the YBI/TI community to assist with the planning of the **Black History Month Celebration and Chinese New Year Celebrations**
- **Free Tax Help:** One TI will officially open our VITA Tax site on February 12<sup>th</sup>. Residents can sign up now for a free tax appointment to file taxes with us at Sherry Williams Community Center (SWCC).
- **NERT Training:** NERT training began in January 2026, and 88 participants attended the first day of training. We are pleased to report that Job Corps students showed up in force to learn about disaster preparedness and gain crucial skills in the event of an emergency.

### **Special Programming & Projects**

One TI is finalizing interviews for the Ambassador Program and is planning on rolling out Health & Wellness Programming in the first quarter of the year.

# Treasure Island Museum

Report to TIDA ~ End of Year, 2025



**In 2025, our staff and community volunteers have:**

- **broadened our membership and donor base significantly** by appealing directly to the community and local businesses; funds raised offset the cost of rehabilitating and revitalizing a room in historic Treasure Island Building One, creating a new well-appointed public space that will open in early 2026.
- **published monthly e-newsletters** that encourage visitorship by promoting Treasure Island's many attractions, neighborhood businesses, and new outdoor spaces.
- **expanded our collection by accessioning Pan American Airways memorabilia**, as well as primary sources and original works of art from the Golden Gate International Exposition.
- **joined One Treasure Island staff at their community celebrations**; the museum typically hosts the youth activity table, installs decorations, and contributes historic context for each event.



## **Treasure Island Museum's reputation continues to expand:**

**As the island's redevelopment sparks renewed interest in its unique history,** the museum has become a trusted source of information, as well as a repository of images to illustrate its past.

**In addition to our museum education programs and tours,** our staff and volunteers regularly assist historians, educators, as well as local television and radio stations.

**The museum ensures that island visitors leave with a deeper appreciation** for the layers of meaning that underlie this unique neighborhood.







**Our museum education programs engage diverse audiences of lifelong learners:**

**Our *Little Island, Big Ideas* series** features education programs on a wide range of topics, presented live and virtually.

**Docent-led tours** of historic Building One and points of interest on the island are offered on a regular basis, as well as on request.

**Our free public gallery in Building One** offers a timeline of island history, serving as both an information center and the first stop for many visitors.

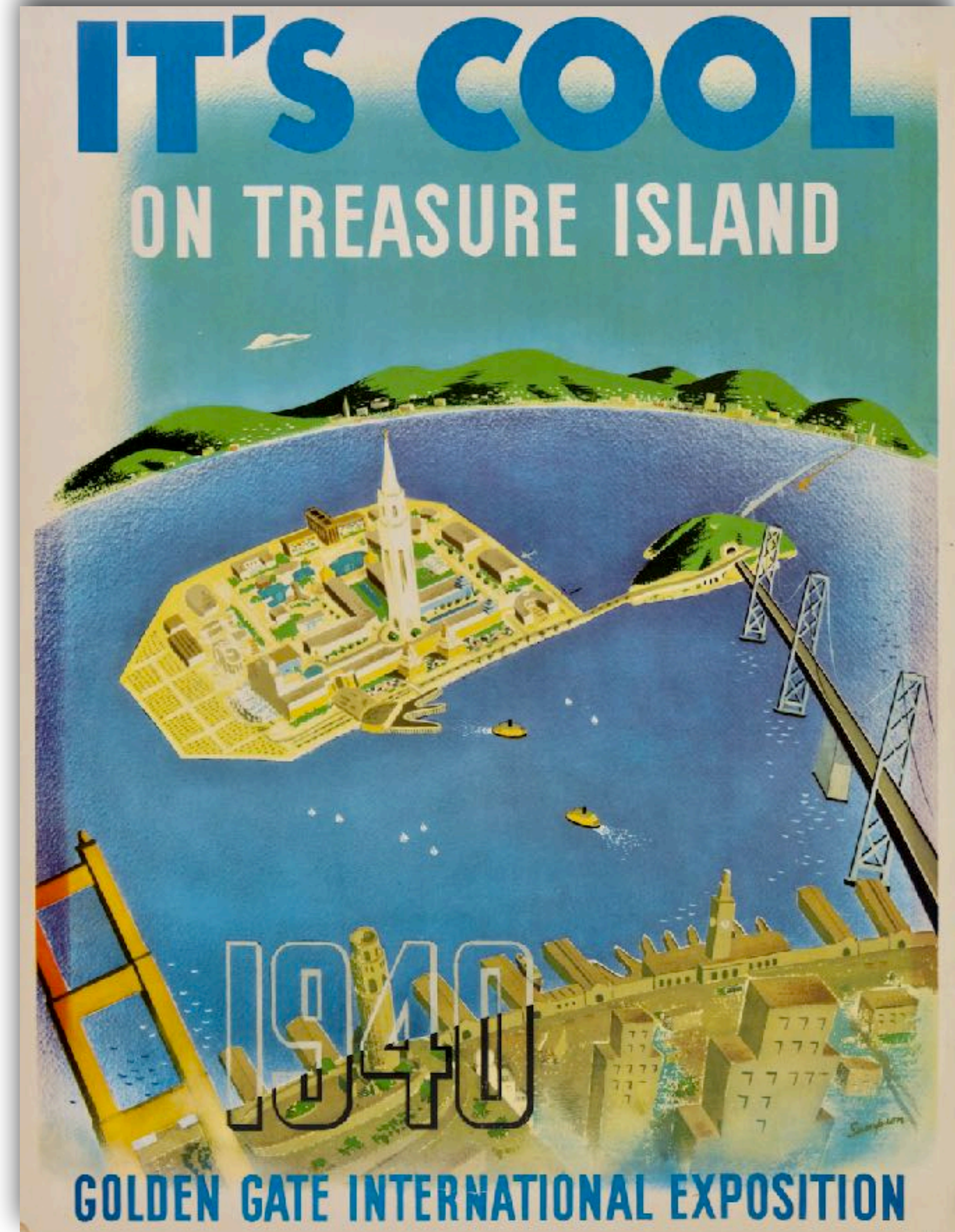


## **Our service to the Treasure Island Community continues:**

## **Infrastructure and Revitalization Financing District No. 1 (Treasure Island)**

**Tax Increment Revenue Bonds, Series 2025A (Facilities Increment)**

**Tax Increment Revenue Bonds, Series 2025B (Housing Increment)**

On Thursday, November 20, 2025, the City and County of San Francisco (the "City") priced the third issuance of \$27.2 million in Tax Increment Revenue Bonds for its Infrastructure and Revitalization Financing District ("IRFD") No. 1 (Treasure Island), consisting of \$22.4 million Series 2025A



(Facilities Increment) (the "2025A IRFD Bonds") and \$4.7 million Series 2025B (Housing Increment) (the "2025B IRFD Bonds") (together, the "IRFD Bonds").

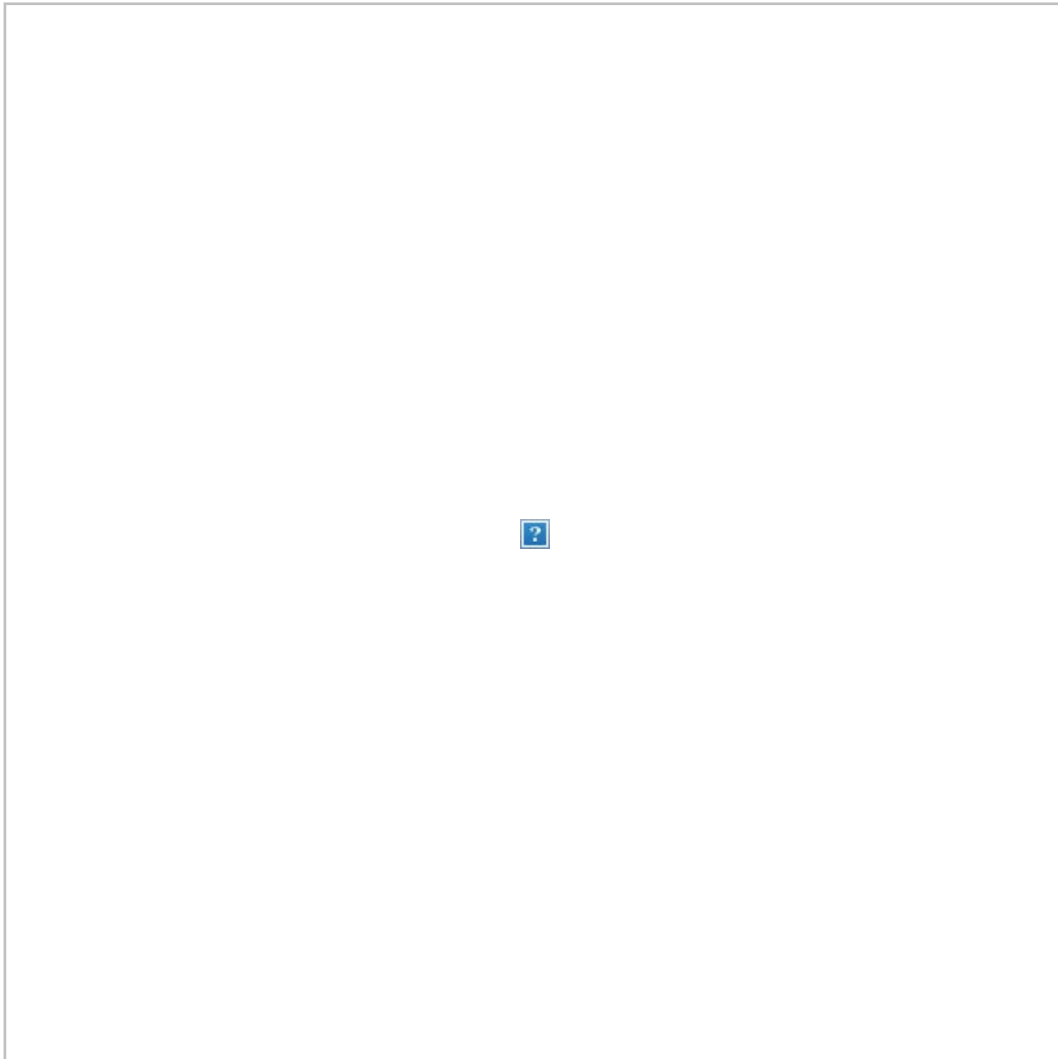

## The Project

The Treasure Island Project consists of approximately 461 acres entitled for the development of 8,000 residential units, approximately 140,000 square feet of new commercial and retail space, adaptive reuse of three historic buildings with 311,000 square feet of commercial/flex space, 500 hotel rooms, approximately 100,000 square feet of office space, over 290 acres of open space, 22 miles of walking/biking paths, playing fields, a marina, and a ferry terminal.

The Series 2025A IRFD Bonds are being issued to finance the acquisition of certain public facilities and improvements authorized to be financed by the Treasure Island Project, as well as a reserve fund and other costs of issuance related to the transaction.

The Series 2025B IRFD Bonds are being issued to finance the acquisition and construction of affordable housing, as well as a reserve fund and other costs of issuance related to the transaction.

## Sale Results

The IRFD Bonds were sold via a negotiated sale with Stifel, Nicolaus & Company, Inc. serving as the underwriter. The IRFD Bonds received orders from 9 unique institutional investors, resulting in orders totaling \$103.6 million across both series of bonds. The True Interest Cost was 5.11% for the 2025A IRFD Bonds and 5.33% for the 2025B IRFD Bonds.

The Controller's Office of Public Finance would like to thank and congratulate everyone who put in the hard work to successfully bring this transaction to market.
