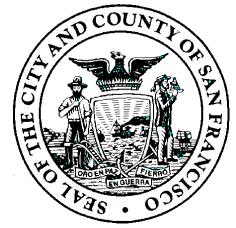

The City’s FY 2026-27 budget, as approved by the Board of Supervisors and signed by the Mayor in July 2025, included a \$17 million reduction in expenditures for Community Based Organizations (CBOs) contracted with the San Francisco Department of Public Health (SFDPH). Over the past several months, SFDPH has held public stakeholder meetings with contracted CBOs to collaboratively discuss how best to achieve \$17 million in budget reductions for the FY 2026-27 budget. This memo outlines how SFDPH plans to achieve \$17 million in contract reductions. SFDPH is accepting written comments on these reductions through February 4, 2026. The vote for this item will take place at the March 2, 2026 Health Commission meeting.
