

The City’s FY 2026-27 budget, as approved by the Board of Supervisors and signed by the Mayor in July 2025, included a \$17 million reduction in expenditures for Community Based Organizations (CBOs) contracted with the San Francisco Department of Public Health (SFDPH). Over the past several months, SFDPH has held public stakeholder meetings with contracted CBOs to collaboratively discuss how best to achieve \$17 million in budget reductions for the FY 2026-27 budget. This memo outlines how SFDPH plans to achieve \$17 million in contract reductions. SFDPH is accepting written comments on these reductions through February 4, 2026. Approval is requested.

INFORMATION REGARDING PROVIDING REMOTE PUBLIC COMMENT FOR THOSE WHO HAVE RECEIVED ACCOMMODATION FOR A DISABILITY FROM THE HEALTH COMMISSION SECRETARY

- Each individual may comment 1 time per agenda item.
- Each individual may speak for up to 3 minutes; after which time the line is automatically silenced.

- After you speak, you will go back to listening mode. You may stay on the line to provide public comment on another item.
