Notice of Temporary Water Service Interruption

Caution: Do Not Use The Water During The Shutdown Period

What: The Treasure Island Development Authority (TIDA) is working with their developer and the San Francisco Public Utilities Commission (SFPUC) to perform water system improvements. You may experience low water pressure at this time. The crew will do its best to minimize the length of the service impact. We sincerely regret this necessary inconvenience to your water service.

When: * 4/19/22 at 9:00 AM to 4/19/22 at 12:00 PM

** Weather/construction issues may postpone this work*

Who: The San Francisco Water Department will perform the work.

Areas Affected: Yerba Buena Island

Important Information:

- If you are a Landlord with tenant(s) in the areas listed above and the SFPUC bill is in your name, it is your responsibility to notify the tenant(s) of the planned service impact.
- Air or sediment may get trapped in your pipe because of this work. Upon restoration of service, we recommend that you slowly turn on the cold water to your bathtub faucet and let the water run for several minutes. This should allow any trapped air or sediment in the pipe to escape.
- To prevent flooding, ensure that no indoor/outdoor plumbing fixtures such as faucets, hoses and appliances are accidentally left on at the time your water service is restored.
- Thank you for your patience and understanding as we continue to improve your local drinking water system.

Traffic Control Advisory

Hillcrest Road - YBI

April 27-29, 2022



Traffic control will be in effect daily starting April 27th through April 29th, 2022 along Yerba Buena Island Hillcrest Road in the direction of the Bay Bridge Eastbound on-ramp. Work hours are between 7:00 A and 5:00 P daily. The paving work is a component of the Southgate Road Realignment Project.

Vehicles leaving YBI toward Oakland during this work may experience delays. Please plan an extra 15 minutes for vehicle trips leaving YBI traveling to the East Bay during workdays. The most significant delays will occur on Friday, April 29, during paving of the EB I-80 on-ramp.

Times: 7:00 AM to 5:00 PM daily

- **Expect delays along YBI Hillcrest Road during work hours.**
- **The roadway width will be reduced to 12 feet. Large semi trucks and towed trailers may be slow through the work area.**
- **There is no impact to the SFMTA MUNI 25-Treasure Island bus route, nor to other YBI on and off-ramps.**

Hillcrest Road - YBI

Update for Friday April 29, 2022



Paving of the roadway along the Yerba Buena Island Bay Bridge Eastbound on-ramp will be performed on Friday, April 29 from 7:00 AM to 5:00 PM. The paving work is component of the Southgate Road Realignment Project.

Vehicles leaving YBI toward Oakland during this Friday work may experience delays up to 20 minutes.

It is advised that vehicles traveling to the East Bay between 7:00 AM and 5:00 PM on Friday minimize delays by traveling into San Francisco using the Bay Bridge Westbound on-ramp via Macalla Road and then return to the East Bay via the Harrison Street exit and the 1st Street On-ramp.

It is advised that vehicles traveling to San Francisco between 7:00 AM and 5:00 PM on Friday also use the Bay Bridge Westbound on-ramp via Macalla Road to avoid potential backups along TI Road

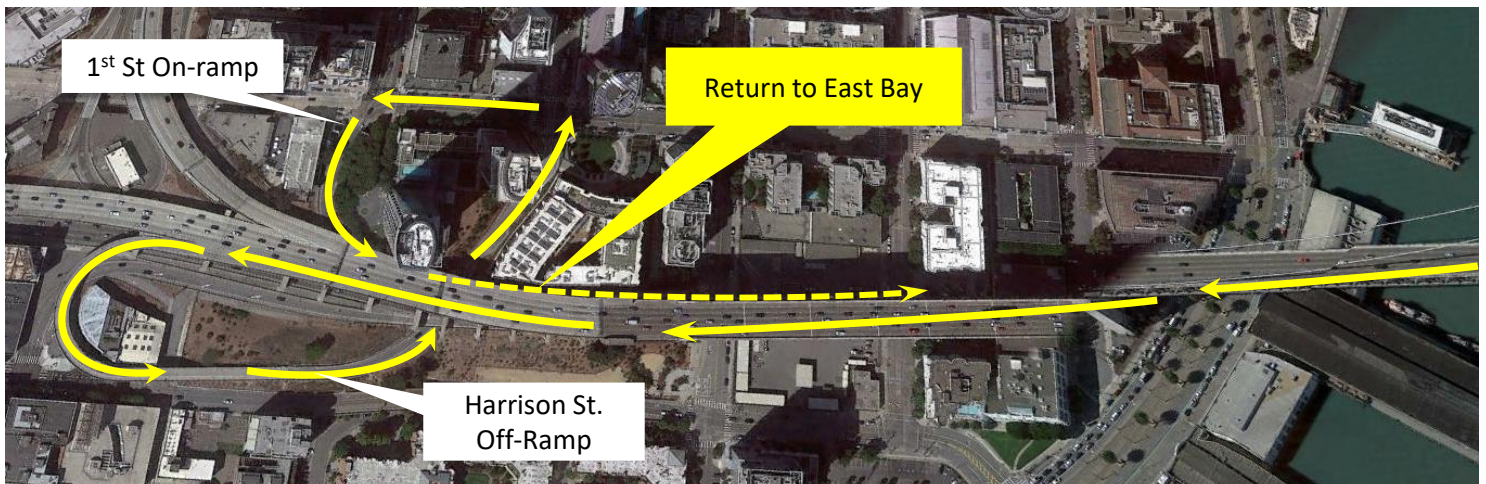

Treasure Island Supplemental Transportation Needs Assessment

In an effort to identify supplemental transportation needs of island residents and workers in addition to the public transportation services planned for Treasure Island, One Treasure Island is working with TIMMA on a Supplemental Transportation Needs Assessment.

This will include doing an island wide survey, forming a working group of residents and workers to inform survey content and give ongoing feedback, hosting focus groups in multiple languages and identifying possible options for supplemental transportation services. The goal is to identify services that meet these needs and then research and apply for funding to support the services. We hope to reach as many island residents and workers for input. 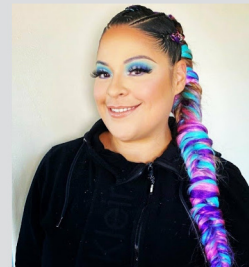

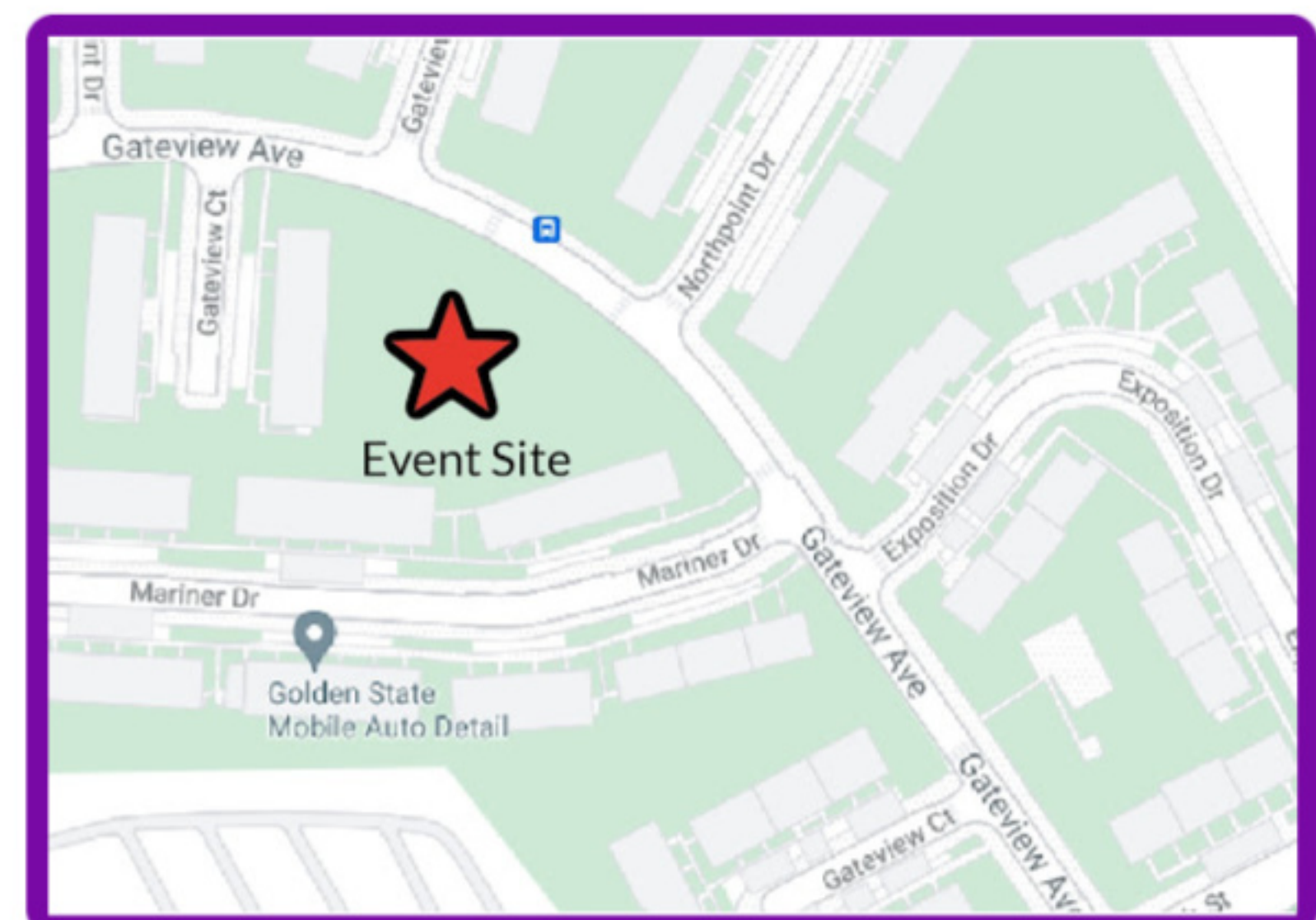

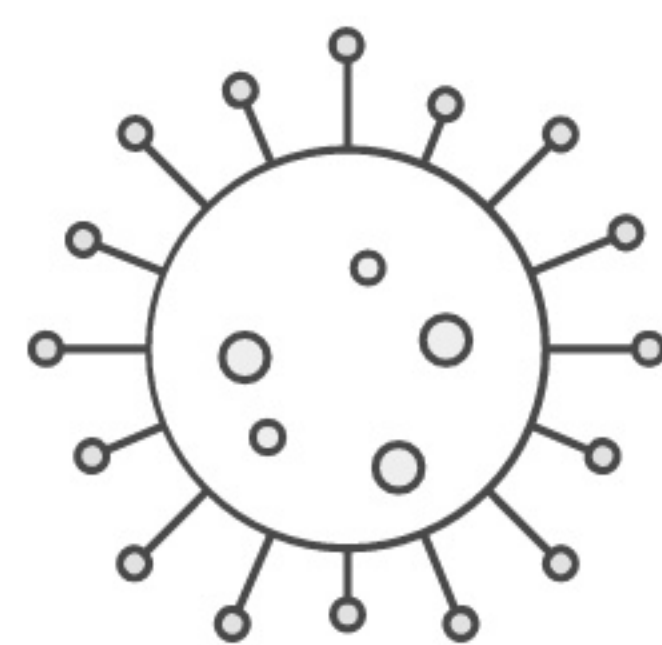

Arrange for regular loads to your Focus Card or Access Account (eg. direct deposit or automated transfers from another account).

For Focus Card: Go to www.usbankfocus.com and open your savings account with just \$10. Set an **automatic savings trigger to save at least \$20 a month.**

For SHFCU: As a member of the credit union your savings account is already open! Go to www.self-helpfcu.org and set up **automatic savings triggers to save at least \$20 a month.**

SPUR Talk: The Transformation of Treasure Island

An entire neighborhood and public park are rapidly taking shape on the leftovers of the U.S. Navy's old base on Treasure Island. "Parks, plazas, promenades, wetlands and natural areas ... all connected by bicycle lanes and pedestrian trails," are coming, explained the Treasure Island Development Authority's V. Fei Tsen during a SPUR panel Thursday afternoon about the past and future of the island. "It will be the biggest addition to the city's park system since Golden Gate Park."

"It's now been almost 30 years since the navy listed the station for closure," said Bob Beck, also with the development authority. "There's been significant progress on the infrastructure side, such as new gas regulators, electrical switchers, and the Public Utilities Commission is taking bids for new construction of a new wastewater treatment plant."

There's also ongoing stabilization work to protect the man-made island from earthquakes and sea-level rise, all in preparation for an entirely new San Francisco neighborhood, with about 27 percent of the housing affordable and the rest market-rate. "The approach is to make it part of San Francisco through urban form, density, and 8,000 new housing units," said Kevin Conger, Principal with CMG Landscape Architect. Those new units will be clustered around the recently opened ferry terminal, to minimize the need for a car. "All of the residential development is within a 15-minute walk of the transit hub," he added. "Providing a high-quality pedestrian environment, prioritizing walking not driving."

That means streets without curbs and with lots of paths and natural vegetation to make walking around and cycling around the island as pleasant as possible.

There will also be public artwork and a promenade. And the hope is to increase ferry service in the future to make getting to and from San Francisco a breeze.

“There will be robust transit options, both with Muni to SF and AC Transit to Oakland,” said Tsen. “It will provide transportation options that lessen the use of the car.”

Although not many of the existing structures were salvageable, said the panelists, an effort is being made to preserve what they can, including Pan Am’s Treasure Island terminal, which welcomes visitors as they arrive by ferry. The island’s historic chapel is being repurposed into a public space as well.

The first phase of housing development in the \$8 billion project will be finished this year, with more coming online in phases. The affordable housing will be prioritized for homeless veterans as a nod to the island’s military past. As to the future, the developments will feature public art, public spaces, and great views of San Francisco. The large park is designed so coastal parts of it can be allowed to transform into wetlands as sea levels rise, to avoid flooding the rest of the island.

“We see ourselves as stewards of the public realm and we have an incredible opportunity to create a new neighborhood of San Francisco,” said Tsen.

Furor Over Proposed San Francisco Treasure Island Toll Upends Assembly Race

AN FRANCISCO (KPIX) — On April 19, voters will choose a new Assembly member to represent about half of San Francisco residents. A proposed toll for Treasure Island is turning former political friends into political foes.

The toll has twice been scheduled for a vote and has twice been pulled from the agenda. It now sits in a kind of political limbo.

The development plan on Yerba Buena island is for 8,000 new housing units and 20,000 new residents. To prevent gridlock, the city is proposing a \$5 toll to enter and exit the island as a way to discourage private vehicles and pay for ferries and public transit. That's a \$10 charge to visitors — \$17 if they have to pay a bridge toll as well. It's an idea that Treasure Island's supervisor, Matt Haney, seemed to support.

"That's to manage congestion on an island that would otherwise be entirely gridlocked," he said. "People who want to go to Treasure Island are going to overwhelmingly take other methods than driving once there are tens of thousands of people that live there."

He said only new residents with presumed higher incomes will pay the toll, while those who already live there will be exempt. Hope Williams, a long-time resident and toll opponent, said that's only half the problem.

"We don't have a store, we don't have a school, we don't have resources," she said. "All of our services rely on coming to the island or for us to come off the island. But, all of our services, all of our support people would have to pay this toll."

The islanders say supervisor Haney used to oppose the toll before he began running for Assembly District 17. Now, they say, he won't even take their phone calls. On Sunday, they invited David Campos, Haney's opponent in the Assembly race, to speak to the group.

"I think they invited me because they feel betrayed by their current supervisor," said Campos. "Here we have a community that has been struggling for years and the city is looking to impose a toll that would be a devastating thing for the community."

Haney doesn't think that's fair.

"The state, by law, requires us to have a toll. It's not something I even have control over," he said. He denied that he was ever totally opposed to the idea. "I've always supported some form of congestion management of a toll that had no impact on the current residents," Haney said.

"He said as long as he's our supervisor he would not allow a toll to come to Treasure Island," said Hope Williams. "And then he said that the toll is required. And now, it's 'We're making exemptions.'"

The toll was set to take effect in 2024, long before most of the new housing is finished. Haney says the vote has been tabled while a new economic-impact study is completed. Toll opponents don't seem willing to wait until then to pick a new ally in the fight.

Treasure Island offramps on Bay Bridge reopen after being closed due to collision

SAN FRANCISCO (KRON) — A traffic obstruction at Treasure Island and Macalla Roads, that had earlier seen both offramps to Treasure Island from the Eastbound and Westbound Interstate 80 closed, has been resolved, according to a [tweet from the San Francisco Department of Emergency Management](#). KRON4 had earlier reached out to the San Francisco Police Department which confirmed that officers from the Southern Station responded to a call of a vehicle collision involving a commercial truck shortly before 8:00 a.m.

“Officers arrived on scene and located a 40 year old white male who is being evaluated for possible injuries,” said SFPD Media Relations representative Allison Maxie in a statement sent to KRON4. “Officers remain on the scene investigating the cause of the collision.”

SFPD’s traffic safety division later sent out a [tweet](#) clarifying the incident as a “solo noninjury collision involving a big rig.” Motorists are still being advised to expect delays and use alternate routes if possible.

City Attorney Sues Companies For Alleged Illegal Dumping On Treasure Island

April 27, 2022

San Francisco City Attorney David Chiu announced Tuesday a lawsuit against three companies alleging they illegally dumped several tons of soil and other materials on Treasure Island in 2019.

The suit was filed against Tip Top Trucking, LLC, Neeve Engineering, Inc., and Neeve's principal, Joseph Lawrence, seeking damages and penalties, after the city spent \$200,000 to have the materials tested and removed, Chiu said in the statement.

"Thousands of San Franciscans live on Treasure Island--it is not a dumping ground," said Chiu. "We are seeking to cover the costs of removing and testing the illegally disposed material, ensuring the City is made whole."

The lawsuit alleges the defendants violated California's Unfair Competition Law by violating the city's illegal dumping ordinance, creating a public nuisance, and trespassing on City property.

The dumping was witnessed in May 2019 on City property near Avenue I and 5th Street by a contractor for the Treasure Island Development Authority. None of the defendants had permission from the City to engage in this activity, Chiu said.

Seaward ho! There's exploring to do on Treasure Island

When some of us were little kids, we wanted to be explorers, finding new worlds and new things. But everything has been discovered already. And all the new worlds are on the internet.

So what's left is to explore your own backyard, to go someplace you have not seen before. I had a free afternoon on a sunny day in the middle of the week, so I explored Treasure Island.

The island is only a 10-minute ferryboat ride from downtown San Francisco, but it's another world, with bits of the past here and there, and a future new neighborhood all around. It's part old Navy base, part small town, part construction zone.

There are wide green lawns, carefully trimmed. The skyline of San Francisco rises just beyond the shoreline, all hills and towers. At the end of one street is the Golden Gate.

It's a quiet island just now. There are three restaurants, two grocery stores, some playing fields, and not much else. About 2,000 people live on the island. It's one of San Francisco's smallest neighborhoods. But just you wait.

"I fell in love with the view," said MeeSun Boice, "Then I fell in love with the island."

Boice is one of the owners of the Mersea bar and restaurant on the north end of Treasure Island, and an enthusiastic booster of the island's present and future.

A quick word about T.I. It is one of those San Francisco places that keep changing. It is an artificial island in the middle of the bay, dredged up out of a shoal in the 1930s, named Treasure Island after the Robert Louis Stevenson story. It was built for the Golden Gate International Exposition that opened in 1939 and ran for a year and a half. Old-timers still remember the 800-foot-tall Tower of the Sun, and the giant statue of Pacifica, goddess of the Pacific Ocean. At night the island was lit up and glittered, like an illusion of a dream city in the middle of the bay.

It was a Navy base after the fair, mostly closed to the public for more than 50 years.

Years of planning followed, and now it's being transformed into a new San Francisco neighborhood. It will be a stunning transformation, with 8,000 new homes, a quarter of them at below-market rates, new parks, some high-rises and public art. It will be the biggest change in the city since old rail yards were turned into Mission Bay.

The ride to the island from the north end of San Francisco's Ferry Building takes only 10 minutes and costs \$5 each way. The boat is small — only 48 passengers — and the crew is friendly. The voyage, especially on the top deck, is spectacular.

Once ashore, it's like walking through a town under construction, or one being rebuilt. You can see the skeleton of a new city neighborhood in the middle of an older one.

There aren't many signs or maps. There was a sign for Woods Island Club, but it's open only Fridays, Saturdays and Sundays, and this was a Wednesday. I'd heard the Mersea restaurant was up the road a bit, so I went, like an urban explorer. Some young people posing for pictures were the only others on the walkway.

Mersea means "island oasis" in Old English, and that's what it is. It is built from a series of cargo containers, arranged around an open air patio, which gives it a sort of castaway South Seas look. The sound system plays Hawaiian music. "We're on island time here," Boice explained, "away from the hustle and bustle of the city."

Boice and her partner, veteran restaurateur Parke Ulrich, opened Mersea in 2018. It was tough going at first — "We took a risk," Boice said — and tougher yet during the pandemic. There were no visitors to Treasure Island, and no deliveries either. "Like being in the middle of nowhere," she said. Things were so tough for island residents that Mersea and the Aracely Cafe gave free meals to islanders.

"We want to be part of the community," she said.

Boice is a story in herself. She was born in Korea, grew up in an orphanage, was adopted by an American Marine, lived in the Midwest, and moved to San Francisco in 2012 to work in tech. She had big ambitions and an eye for opportunity.

"I didn't know a soul here," she said, "not anybody." Not long after her adoptive father died, she saw a business opportunity and switched to restaurants.

"Now look," she said. "I'm a Korean orphan from the Midwest, living the American dream on an island."
