## **PUBLIC COMMENT INFORMATION**

Members of the public may address the Commission for up to three minutes on any matter within the Commission's jurisdiction. The Commission will hear public comment on all agenda items before or during the discussion of the item. The Commission will also hear public comments on items not listed (see Agenda, Item 2).

The Chair may modify the period of time allowed for public comment in the interest of fairness to all those wishing to address the Commission. Speakers shall address their remarks to the Commission as a whole and not to individual Commissioners or Department personnel. The lack of a response by the Commissioners or Department personnel does not necessarily constitute agreement with or support of statements made during public comment.

Public comment may be made:

- 1) In person at the meeting.
- 2) By email to [JUV-ProbationCommission@sfgov.org](mailto:JUV-ProbationCommission@sfgov.org) if received no later than 12:00 pm the Tuesday before the meeting.
- 3) By leaving a voicemail at 415-271-2861. Comments submitted no later than 12:00 pm the Tuesday before the meeting will be read into the record during the meeting and will be treated as a substitute to providing public comment during the meeting.

NOTE: Persons who submit written public comments or voice mail in advance on an agenda item will not be permitted to provide public comment on the same agenda item(s) in person during the meeting.

## **Instructions for Public Comment Callers**

\*Public Comment can be made by phone during the virtual meeting:

1. Call 415-655-0001, enter Access Code 2660 542 5200, then press “#” when asked for ID, and press “#” again.
  - To make a comment, press \*3 (star, three) to raise your hand.
  - You will hear a prompt confirming that your hand has been raised.
  - Please wait until the Host unmutes you and allows you to speak.
  - When it is your turn, you will hear a prompt saying, "You have been unmuted," and you may begin your comment.
  - Please speak only to the entire Council and not to individual members.
  - You will have **3-minutes** to make your public comment.

## **DISABILITY ACCESS & ACCOMMODATION**

Government's duty is to serve the public, reaching its decision in full view of the public. Commissions, boards, councils and other agencies of the City and County exist to conduct the people's business. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review. ## **LOBBYIST ORDINANCE**

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code 2.100] to register and report lobbying activity. JPC procedures do not permit:

- Signs to be brought into the meeting or displayed in the meeting room.
