Need to register to vote or update your voter registration so your ballot is mailed to the correct address? Go to registertovote.ca.gov or contact us to request a paper registration form. The deadline to register and receive a ballot by mail is Monday, May 18. After May 18, voters may still register and vote in person at the City Hall Voting Center or at a polling place on Election Day.



Official ballots and election materials are available in English, Chinese, Spanish, Filipino, and Vietnamese. We also offer reference ballots in Bengali, Burmese, Hindi, Hmong, Japanese, Korean, Mongolian, Thai, and Urdu. To request a ballot and election materials in your preferred language, go to sfelections.gov/language.





What's on the ballot?

In the June 2, 2026, Election, all voters citywide will vote on contests to fill federal, state, and local offices including United States Representative for Districts 11 or 15, State Assembly Member for Districts 17 or 19, one seat on the Board of Education and Superior Court Judge. Voters in Supervisorial Districts 2 and 4 will also vote to elect their Supervisor.

Voters will also vote on several local ballot measures including an Earthquake Safety and Emergency Response Bond, a Charter Amendment regarding lifetime term limits for the Mayor and members of the Board of Supervisors, and two Business Tax Ordinances.

To learn about the candidates and ballot measures appearing on the June 2 ballot, voters can review the local Voter Information Pamphlet and the state Voter Information Guide, both mailed in May.

Most voters do not need to show identification when voting.

A voter will be asked to show ID if they are voting for the first time in a federal election, such as the June 2, 2026, Election, and did not provide a driver license number, state ID number, or the last four digits of your Social Security number on your registration form. If this applies to you, please bring identification if you plan on voting in person at the City Hall Voting Center or at a polling place on Election Day.

Acceptable forms of ID include a recent utility bill, your sample ballot booklet, a document issued by a government agency, a passport, a driver license or state ID card, or a student ID card that shows your name and photo.

What are my voting options?

1. Vote by Mail

In early May, the Department of Elections will send a vote-by-mail packet, with an official ballot, instructions, an "I Voted!" sticker, and a postage-paid return envelope to every locally registered voter. The online accessible vote-by-mail system -- with screen readable ballots compatible with personal assistive devices -- will also open to all voters at sfelections.gov/access.

Whether you use a paper or accessible ballot, you will need to complete three steps:

The Department of Elections offers 37 official ballot drop boxes in neighborhoods across San Francisco. These boxes will be open 24 hours a day from May 4 through 8 p.m. on Election Day, June 2. For locations, visit sfelections.gov/balldropoff.

2. Vote Early at City Hall

The City Hall Voting Center will be open to all San Franciscans who wish to register to vote, vote in person, use accessible voting equipment, receive personal assistance, or return their mailed ballots:

- Every weekday, May 4 to June 2 (except May 25, Memorial Day), from 8 a.m. to 5 p.m.
- Saturday and Sunday, May 23-24 and May 30-31, from 10 a.m. to 4 p.m.
- Election Day, Tuesday, June 2, from 7 a.m. to 8 p.m.

3. Vote at your Polling Place

Between 7 a.m. and 8 p.m. on Election Day, 501 polling places will be open for in-person voting and ballot drop-off services. Over 2,000 poll workers, many of whom are bilingual, will be available to assist voters in their preferred language at polling places on Election Day. The address of your polling place, along with accessibility information, will be printed on the back cover of your Voter Information Pamphlet (mailed in May).
