COVID 19 Island-wide Services Coordination

COVID testing and vaccines continue. One Treasure Island still has At-Home COVID tests to distribute to the Treasure Island community for residents who have been exposed to COVID.

Food Pantry

We continue to operate the weekly Food Pantry on Tuesdays with an average of 120 households accessing the pantry.

• One Treasure Island Programming:

CTP 12 began on June 6th and will run through July 29th. There are currently 15 participants in the program and some have begun to interview for employment.

• Ship Shape Community Center

The Ship Shape Community Center mask policy remains in place until further notice. We will continue to monitor COVID safety recommendations and act accordingly moving forward.

Outreach & Social Media

Community engagement continues through social media posts, posts on Next Door Treasure Island, fliers on the community boards, in weekly pantry bags and through partnership with the TI housing providers.

Supplemental Transportation Study Workgroup

The Supplemental Transportation Study workgroup will meet this evening to review the survey results. 196 surveys were completed. One TI will present the survey results at the next TIDA BOD meeting if permitted. Focus groups dates are in late August to ensure that we have an opportunity to analyze the data from the workgroup and STS survey. The plan is to provide the TIMMA BOD, the TIDA BOD and the CAB with recommendations for supplemental transportation options at their September meetings.

Community Events

The Oral History Project grand opening was a big success and banners of the OHP participants are currently located in Building 1. The exhibit will be open through August 31, 2022.

An Emergency Prep Workshop was held on June 4^{th.} Attendance was low as only 7 residents attended the workshop, although over 15 registered for the class. One TI hosted a beginner's self-defense workshop on June 14th and it was a successful class although attendance was not high.

Treasure Island marched in the SF Pride Parade on June 26th and it was a big success. Several residents from TI marched with One TI and we all had a great time celebrating SF Pride!

In partnership with TIDA, One TI hosted the 3^{rd} Island Wide Community meeting on June 15^{th} from 6:00 - 7:30 PM. Nineteen individuals participated in the

meeting. Topics discussed included community updates, a presentation by the SF Public Library and SFPD. The next community meeting will be held on August 17, 2022.
