On August 16th at approximately 11:50 PM a portion of Treasure Island housing experienced a power outage. SFPUC dispatched crews, issued an I-Info Alert and notified TIDA and DEM, who issued an AlertSF. Service was restored to the outage area at approximately 9:00 PM on Sunday August 17th save for one property which was connected to generator power. The remaining property was restored to grid power at approximately 1:30 PM on Monday August 18th. Cause was identified by field crews as a faulty transformer serving Buildings 1305 and 1307.

On August 26th at approximately 8:50 AM a portion of Treasure Island experienced a power outage. SFPUC dispatched crews, issued an I-Info Alert and notified TIDA and DEM, who issued an AlertSF. Service was restored to a majority of the service area at approximately 10:00 AM, and was restored to the remaining affected properties at approximately 9:45 PM except for 1316 and 1318 Gateview which were connected to generator power. The remaining properties were restored to grid power on Wednesday August 27th at approximately 5:30 PM. Cause was identified by field crews as a fault in an underground line serving Gateview and Avenue B.

Re: Treasure Island western shoreline rip-rap cleanup

In early September, TIDA contractor Habitat Potential conducted a marine debris removal operation along the Island's southwestern shoreline riprap. The effort resulted in nearly 10 full bags of trash, a car tire, a mattress and several other oversize items being removed from the rip-rap. Debris removal was conducted all the way down to the tideline, using appropriate safety techniques.

Due to its central Bay location, Treasure Island's exposed western shoreline serves as an unfortunate catchpoint for floating marine debris of all sorts. Rip-rap debris removal operations allow for the natural intertidal marine environment existing within the rip-rap to flourish while assuring an aesthetically pleasing shoreline for Landing Park visitors and Treasure Island ferry passengers.

August 2025 RPD TIDA Landscape Report

Month Overview:

Brandon and Joseph attended the bi-weekly field tours with TIDA, Rubicon and SF Environment Department. Areas of discussion began with Panorama Park and the Ceanothus plantings and the barrier stakes. We also discussed Cityside Park and the current state of the landscape and the upcoming opening. We spoke about the Stormwater Gardens and reviewed bare areas for best maintenance practices. Landing Park was another topic and the ongoing maintenance of the landscape. We discussed the plan of some trial areas that we could install and monitor potential species of plants that could be successful on TI/YBI. We also discussed the ongoing issues of nozzles clogging with sediment in several areas of the irrigation. We also discussed the potential areas for tree plantings from the contractor's requirement to replace tree removals. Lastly, SFRPD's Natural Resource Division has been out to review the natural areas of YBI.

Panorama Park

The final fixed point for the relocation of the ceanothus on the west mound has been confirmed. Rubicon is scheduled to begin the relocation early next week. Concurrently, they will modify the existing barrier stakes surrounding the mounds by shortening them to approximately 2–3 inches above the lower rope line. This adjustment will result in a single rope line, with the stakes reduced to about one-half to one-third of their current height. This is an interim measure, as the ropes and wooden stakes are planned to be replaced with a more refined, long-term solution.

Cityside Park

Although the site was not visited this week, observations from last week's walkthrough with Magda were reviewed. Encouraging signs of recovery are emerging among the Island Oaks and eucalyptus trees, with new growth attributed to increased irrigation—an arborist-recommended response to wind exposure damage. However, the sycamores within the rainwater basins continue to struggle. Significant work remains on-site in preparation for the September 13th grand opening.

Landing Park

Rubicon is set to begin grass maintenance and cutback in early fall. In tandem with enhanced irrigation efforts, an experimental increase in water supply will be directed to the Island Oaks on the north end of the park to assess potential improvements in growth and structure. Additionally, unusual symbols frequently burned into the lawn were discussed with Brandon and Joe to determine if similar incidents have been observed elsewhere. Rubicon will prioritize work at Landing Park in the lead-up to the Cityside grand opening.

West Stormwater Garden

There was talk about some bare areas of the garden and why they were there. Rubicon will monitor the areas, and it was decided to wait through Fall to see what type of growth and recovery will happen when the weather cools and the rains come. Rubicon cut back growth to expose the irrigation for greater coverage.

Trial Planting Areas

We had a group discussion about potential areas that we could test plant species to see what would be viable options for future parks and replacements. Joe and Peter B have made suggestions on a plant list and that list was discussed and paired down. Next steps will be to identify the areas and test for suitability. Rubicon will be digging some test holes to see what the soil quality is like in potential sites.

Irrigation Issues

We are trying to identify the issues of clogged nozzles and sediment in the irrigation. Brandon is going to contact his internal and PUC counterpart to see what experience and recommendations they may have. In the meantime, we are researching sand traps/filters and their possible help for this issue.

Natural Areas

Carol Sionkowski, Christopher Campbell, Peter S, and Peter B met to discuss, review, and learn about the Natural Areas on YBI. There will be future visits to complete the tour. Topics of discussion surrounded the definitions of these areas, the current maintenance program, and downloading general knowledge about these areas.

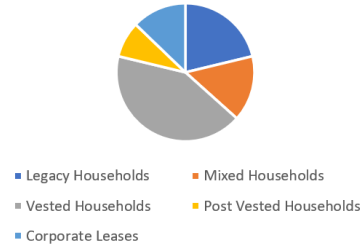

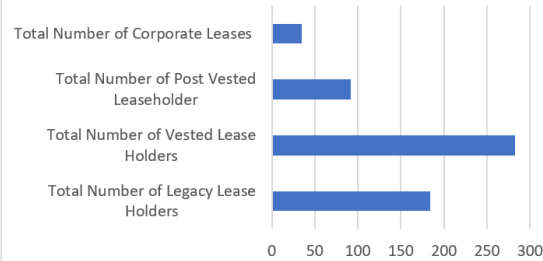

Resident Engagement:

In July, TI Advisors worked with households that received second move notices, and all have made their decisions regarding their next steps. Residents have selected one of the following benefits available to them: accept a transition unit, take an in-lieu payment and move off the Island, or wait to purchase a unit at 490 Avenue of the Palms through DAHLIA's First Time Homebuyer Education program. It is important to note that households aiming to buy a unit at 490 Avenue of the Palms have also clearly decided on an alternative plan if their purchase is unsuccessful. These plans include either taking a transition unit at Star View Court or moving off the Island and taking an in-lieu payment; both options are not available.



Premarketing information for 490 Avenue of the Palms has been distributed to all residents. While TI Advisors are still awaiting details on pricing, all residents have received information and guidance on the First Time Homebuyer Program and Area Median Income (AMI) requirements. This information was shared via e-blast and doorhangers to ensure broad outreach. As always, Legacy and Vested residents can use their Treasure Island Resident Number (TIR) to receive preference when applying for units at 490 Avenue of the Palms. TI Advisors have also developed public premarketing information that will be posted this month in all community spaces on the Island. Residents can find information through posters, flyers, and retractable banners throughout the island this upcoming month.

TI Advisors are informing residents about upcoming opportunities to connect in person and receive important updates. In August, residents will have the chance to meet TI Advisors at two Open House events. In these events, residents can expect to learn about housing updates, park developments, parking, and other collaborative efforts to support both current and future residents. To promote these events, residents will receive both doorhangers and e-blasts with event details and RSVP links.

TI Advisors are supporting resident submission of a grievance for additional eligibility under the Transition Housing Rules and Regulations. This includes direct communications and meetings with residents, requests for supporting documentation, and coordination of a meeting with the Director to hear their grievance requests.

Lastly, TI Advisors have been working with vested residents in mixed households to process their fixed moving payment. This benefit is available only to households that have received a formal move notice and have a legacy adult who is eligible for benefits.

Since the last update, our staff and community volunteers have:

- **partnered with other organizations in the Port Chicago Alliance** to host a weekend of events marking the 81st anniversary of the 1944 disaster and the mutiny trial (held on Yerba Buena Island) that followed.
- **hosted walking tours of Building One and Treasure Island** for groups of students, seniors, new residents, and members of the Coast Guard.
- **offered a free public education program**, in person and online: *Useful and Beautiful: The Decorative Arts Pavilion on Treasure Island*.
- **expanded our collection by accessioning works by Friedolin Kessler**, an artist who bicycled across the state in the early 1930s and documented the California Missions in sketches and prints that were later exhibited at the Golden Gate International Exposition on Treasure Island.
- **scheduled our annual Swing Dance Benefit**; the event on Saturday, October 18 will be a celebration of the museum's golden anniversary.
