# 5. Approval of the Draft Amendments to the Data Management Policy (Action Item)

Soumya Kalra and Daniel Tonkovich presented proposed amendments to the Data Management Policy originally approved in January 2019. The updated policy was presented as a discussion item at the September 26, 2025, COIT Meeting.

Committee members recommended adding language regarding exceptions for charter departments. DataSF clarified that the policy addresses overall data management, not solely data shared with the Unified Data Platform. Additionally, it was noted that the cited regulations pertain to specific types of data, rather than encompassing all departmental data.

There was no public comment.

Mayor's Office made a motion to approve the amended Data Management Policy with the addition of the City Charter to the exceptions section.

### 6. DataSF Update (Discussion Item)

Soumya Kalra discussed DataSF's Unified Data Platform and its implementation strategy, highlighting key areas such as foundational governance, pilot expansion and culture building, and the roadmap toward citywide scale and innovation.

Committee members emphasized the importance of aligning data models used in public-facing analytics to support cross-departmental collaboration. They discussed the need for a clear process to reconcile differing data definitions between state and federal agencies.

There was no public comment.

# 7. Overview of Digital Equity Strategic Plan (Discussion Item)

Rey Lachaux from the Mayor's Office of Housing and Community Development (MOHCD) presented on the Digital Equity Strategic Plan, highlighting the importance of digital equity, the current digital divide in San Francisco, and opportunities for COIT members to provide support.

Committee members emphasized that investing in digital equity will deliver long-term benefits and stressed the need for sustainable solutions, potentially including updates to administrative code and metrics. Members also sought clarity on roles, responsibilities, and expectations for continued engagement. The Mayor's Office of Housing and Community Development highlighted the importance of data to guide and strengthen the strategic plan.

There was no public comment.

# 8. Mayor's Office of Innovation Update (Discussion Item)

Florence Simon provided an overview of the Mayor's Office of Innovation, highlighting key project workstreams focused on homelessness, permitting, police recruitment, violence prevention, and enhancing the customer experience with Muni.

# 9. Digital Services Update (Discussion Item)

Cyd Harrell provided an overview of Digital Services, with a focus on SF.gov, Forms on SF.gov, and customer experience metrics.

Committee members inquired whether the forms workstream is intended exclusively for SF.gov and whether data submitted through the forms would be directed to DataSF. Cyd confirmed that the forms are currently limited to SF.gov and clarified that a public-facing customer login feature is not on the roadmap at this time. Committee members expressed interest in enabling users to save their information and carry it over across multiple forms.

#### 11. Chief Information Officer Update

Jane Gong provided an update on the artificial intelligence initiatives her team has implemented, including the deployment of AI tools for staff use, the development of an AI Playbook, exploration of an AI Risk Management Framework, and the plans for San Francisco AI Week in December. Mike Makstman gave an overview of the revised Drone Policy, highlighting plans for collective procurement and the development of a unified airspace standard.

Committee members advised staff to carefully evaluate the maintenance and operational costs of AI applications, and to assess the specific needs and budget implications for each department before developing a pilot program.
