ARF has created an environment that supports his health, stability and quality of life in a way no other facility have matched closing ARF would not only displace vulnerable residents like my brother but also dismantle a vital community resource that have proven itself capable of providing high quality care. It would undo years of progress in his well-being and cause unnecessary hardship. I urge you to reconsider this decision and explore every possible option to keep ARF open. Hi my name is Naomi Marcus a voter in San Francisco and the retiree from UCSF department or psychiatry I'm calling to voice my opposition to closing the adult residential facility located at General Hospital I worked with many of the patients when I was working at UCSF and they all are doing so well at the ARF, the Adult Residential Facility, and closing that place where they get specialized care maintained in a safe and dignified scenario will really be catastrophic for many of their mental and physical health and I'm just very concerned that that would even be considered. I know many of those patients from my work as a vocational rehabilitation counselor at UCSF, I helped many of those people get jobs and get placements and they all do so much better at the ARF than they ever did and private board and care homes. I was told by the ARF unit at San Francisco General to leave a voicemail message here. I'm trying to express what harm closing the ARF Unit at General Hospital will do to my daughter she's a resident there she and at the ARF unit chief they actually pay attention to them and their welfare, their comings and goings, if they don't show up for curfew they know it and report it. My daughter, over the past 20 years, she's for 20 years she's been in and out a few of the third party for hire group homes and we've had horrible experiences there is the worst is when my daughter's gone missing for days and weeks at a time, nobody reports her missing at these group homes. Whereas, with RF they would take immediate action, report it to the police for a missing at-risk person, such as my daughter,

as it was suggested to me to do so; because, I see no sense in closing or rather, moving the patients at the ARF unit into various other group homes methods to make room for others supposedly mentally ill patients. Its like dumping one set of people out and moving another set of people in, which puts my daughter and her fellow patients at the ARF unit at serious, serious risk. I don't see the sense. I'm asking you please, please don't do this.
