The Commission will hear public comment on all agenda items before or during the discussion of the item. The Commission will also hear public comments on items not listed (see Agenda, Item 2).

The Chair may modify the period of time allowed for public comment in the interest of fairness to all those wishing to address the Commission. Speakers shall address their remarks to the Commission as a whole and not to individual Commissioners or Department personnel. The lack of a response by the Commissioners or Department personnel does not necessarily constitute agreement with or support of statements made during public comment.

Public comment may be made:

- 1) In person at the meeting.
- 2) By email to <u>JUV-ProbationCommission@sfgov.org</u> if received no later than 12:00 pm the Tuesday before the meeting.
- 3) By leaving a voicemail at 415-271-2861. Comments submitted no later than 12:00 pm the Tuesday before the meeting will be read into the record during the meeting and will be treated as a substitute to providing public comment during the meeting.

NOTE: Persons who submit written public comments or voice mail in advance on an agenda item will not be permitted to provide public comment on the same agenda item(s) in person during the meeting.

LOBBYIST ORDINANCE

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code 2.100] to register and report lobbying activity. <u>MEETING AND AGENDAS POLICIES</u> Citizens are encouraged to testify in person at JPC Meetings and/or write letters to the JPC and to its members: c/o Juvenile Probation Commission, 375 Woodside Avenue, San Francisco, CA 94127.

JPC procedures do not permit:

- Persons in the audience to vocally express support or opposition to statements by Commissioners or by other persons testifying;

- Signs to be brought into the meeting or displayed in the meeting room.
