NOTICE OF COMMISSION HEARING POLICIES AND PROCEDURES

A. Commission Office

The Civil Service Commission office is located at, 25 Van Ness Avenue, Suite 720, San Francisco, CA 94102. The telephone number is (628) 652-1100. The fax number is (628) 652-1109. The email address is civilservice@sfgov.org and the web address is www.sfgov.org/civilservice/. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday.

B. Policy Requiring Written Reports

It is the policy of the Civil Service Commission that except for appeals filed under Civil Service Commission Rule 111A Position-Based Testing, all items appearing on its agenda be supported by a written report prepared by Commission or departmental staff. All documents referred to in any Agenda Document are posted adjacent to the Agenda, or if more than one (1) page in length, available for public inspection and copying at the Civil Service Commission office. Reports from City and County personnel supporting agenda items are submitted in accordance with the procedures established by the Executive Officer. Reports not submitted according to procedures, in the format and quantity required, and by the deadline, will not be calendared.

C. Policy on Written Submissions by Appellants

All written material submitted by appellants to be considered by the Commission in support of an agenda item shall be submitted to the Commission office, no later than 5:00 p.m. on the fourth (4th) business day preceding the Commission meeting for which the item is calendared (ordinarily, on Tuesday). An original copy on 8 1/2-inch X 11 inch paper, three-hole punched on left margin, and page numbered in the bottom center margin, shall be provided. Written material submitted for the Commission's review becomes part of a public record and shall be open for public inspection.

D. Policy on Materials being Considered by the Commission

Copies of all staff reports and materials being considered by the Civil Service Commission are available for public view 72 hours prior to the Civil Service Commission meeting on the Civil Service Commission's website at https://sf.gov/civilservice and in its office located at 25 Van Ness Avenue, Suite 720, San Francisco, CA 94102. If any materials related to an item on this agenda have been distributed to the Civil Service Commission after distribution of the agenda packet, those materials will be available for public inspection at the Civil Service Commission's during normal office hours (8:00 a.m. to 5:00 p.m. Monday through Friday).

E. Policy and Procedure for Hearings to be Scheduled after 5:00 p.m. and Requests for Postponement

A request to hear an item after 5:00 p.m. should be directed to the Executive Officer as soon as possible following the receipt of notification of an upcoming hearing. Requests may be made by telephone at (628) 652-1100 and confirmed in writing or by fax at (628) 652-1109.

A request for a postponement (continuance) to delay an item to another meeting may be directed to the Commission Executive Officer by telephone or in writing. Before acting, the Executive Officer may refer certain requests to another City official for recommendation. Telephone requests must be confirmed in writing prior to the meeting. Immediately following the "Announcement of Changes" portion of the agenda at the beginning of the meeting, the Commission will consider a request for a postponement that has been previously denied. Appeals filed under Civil Service Commission Rule 111A Position-Based Testing shall be considered on the date it is calendared for hearing except under extraordinary circumstances and upon mutual agreement between the appellant and the Department of Human Resources.

F. Policy and Procedure on Hearing Items Out of Order

Requests to hear items out of order are to be directed to the Commission President at the beginning of the agenda. The President will rule on each request. Such requests may be granted with mutual agreement among the affected parties.

G. Procedure for Commission Hearings

All Commission hearings on disputed matters shall conform to the following procedures: The Commission reserves the right to question each party during its presentation and, in its discretion, to modify any time allocations and requirements.

If a matter is severed from the *Consent Agenda* or the *Ratification Agenda*, presentation by the opponent will be for a maximum time limit of five (5) minutes and response by the departmental representative for a maximum time limit of five (5) minutes. Requests by the public to sever items from the [Consent Agenda or] Ratification Agenda must be provided with justification for the record.

For items on the *Regular Agenda*, presentation by the departmental representative for a maximum time of five (5) minutes and response by the opponent for a maximum time limit of five (5) minutes.

For items on the Separations Agenda, presentation by the department followed by the employee's

representative shall be for a maximum time limit of ten (10) minutes for each party unless extended by the Commission.

Each presentation shall conform to the following:

- 1. Opening summary of case (brief overview);
- 2. Discussion of evidence;
- 3. Corroborating witnesses, if necessary; and
- 4. Closing remarks.

The Commission may allocate five (5) minutes for each side to rebut evidence presented by the other side.

H. Policy on Audio Recording of Commission Meetings

As provided in the San Francisco Sunshine Ordinance, all Commission meetings are audio recorded in digital form. These audio recordings of open sessions are available starting on the day after the Commission meeting on the Civil Service Commission website at www.sfgov.org/civilservice/.

I. Speaking before the Civil Service Commission

Speaker cards are not required. The Commission will take in-person public comment on all items appearing on the agenda at the time the item is heard. The Commission will take public comment on matters not on the Agenda, but within the jurisdiction of the Commission during the "Requests to Speak" portion of the regular meeting. Maximum time will be three (3) minutes. A subsequent comment after the three (3) minute period is limited to one (1) minute. The timer shall be in operation during public comment. Upon any specific request by a Commissioner, time may be extended. People who have received an accommodation due to a disability (as described below) may provide their public comments remotely. The Commission will also allow public comment from members of the public who choose to participate remotely. It is possible that the Commission may experience technical challenges that interfere with the ability of members of the public to participate in the meeting remotely. If that happens, the Commission will attempt to correct the problem, but may continue the hearing so long as people attending in-person are able to observe and offer public comment.

J. Public Comment and Due Process

During general public comment, members of the public sometimes wish to address the Civil Service Commission regarding matters that may come before the Commission in its capacity as an adjudicative body. The Commission does not restrict this use of general public comment. To protect the due process rights of parties to its adjudicative proceedings, however, the Commission will not consider, in connection with any adjudicative proceeding, statements made during general public comment. If members of the public have information that they believe to be relevant to a mater that will come before the Commission in its adjudicative capacity, they may wish to address the Commission during the public comment portion of that adjudicative proceeding. The Commission will not consider public comment in connection with an adjudicative proceeding without providing the parties an opportunity to respond.

K. Policy on use of Cell Phones, Pagers and Similar Sound-Producing Electronic Devices at and During Public Meetings

The ringing and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at this meeting. Please be advised that the Chair may order the removal from the meeting room of any person(s) responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices.

Information on Disability Access

* Temporary Wheelchair-accessible entrances are located on Van Ness Avenue and Grove Street. Please note the wheelchair lift at the Goodlett Place/Polk Street is temporarily not available. After multiple repairs that were followed by additional breakdowns, the wheelchair lift at the Goodlett/Polk entrance is being replaced for improved operation and reliability.

The Civil Service Commission normally meets in Room 400 (Fourth Floor) City Hall, 1 Dr. Carlton B. Goodlett Place. However, meetings not held in this room are conducted in the Civic Center area. City Hall is wheelchair accessible. The closest accessible BART station is the Civic Center, located 2 ½ blocks from City Hall. Accessible MUNI lines serving City Hall are 47 Van Ness Avenue, 9 San Bruno and 71 Haight/Noriega, as well as the METRO stations at Van Ness and Market and at Civic Center. Accessible curbside parking has been designated at points in the vicinity of City Hall adjacent to Grove Street and Van Ness Avenue.

Attachment A – SUPPLEMENTAL REPORT

Project Background

The Airport Security Infrastructure Program (ASIP) Phase 2 Project (Project) would design and construct a new security surveillance system and upgrade existing infrastructure. The Project will improve security and operational efficiency through the installation of closed-circuit television cameras, supporting infrastructure, and the integration of systems – the replacement of obsolete devices and infrastructure is essential.

This project is complex due to the required integration of various devices, Video Management Systems, Situational Awareness systems, and multiple Airport networks (SLAN and SFONet). Successful integration into existing systems necessitates a dedicated team that can collaborate with multiple stakeholders, technical experts, and SFO staff. The new installation must be integrated with existing Special Systems Rooms while minimizing any impact on travelers. Additionally, ASIP Phase 2 consists of multiple locations across the campus, where construction may occur simultaneously, so maintaining live airport operations throughout the project is key.

To manage this level of technical complexity and maintain continuous operations, the Airport will deliver this project through a Progressive Design Build (PDB) method. The PDB method integrates programming, design, construction, commissioning, and activation under a single contract. This approach requires continuous collaboration among specialists in design, operations, cost estimating, scheduling, commissioning, and airport special systems. Unlike traditional design-bid-build delivery, where work elements can be separated, the PDB model requires all components to be designed and executed in tandem as one interdependent scope.

Effective implementation of the PDB model depends on its comprehensive stakeholder engagement process (SEP), which is a close collaboration between City staff, airport stakeholders, and consultants throughout all project phases. The City staff are involved from the beginning and play a key role in ensuring regulatory compliance and supporting operational success. Project teams must secure buy-in from both stakeholders and City staff to move forward effectively.

Staffing Plan

The Airport is committed to providing and developing in-house staff to support on-going capital improvements. Design & Construction division currently employes approximately 157 personnel, that include architects, engineers, planners, construction managers and inspectors, contracts staff, project managers and project controls specialists. The division's current budget includes approximately 78 vacancies, with an estimated 35 positions currently in the process of being filled.

The Airport's staffing approach combines a strong City staff-led effort with integrated consultant support. Airport architects, engineers, and project managers retain full management control, set priorities, review deliverables, as well as engage with Airport's stakeholders including Building Inspection and Code Enforcement, the City Attorney's office, and others to ensure compliance with City and Federal regulations, Airport standards, and strategic objectives. Our staff is engaged in guiding the project needs and compliance from day 1 of programming through commissioning and final acceptance.

Delivering a project of this complexity under a PDB method requires a depth of multidisciplinary expertise and real-time coordination that is not available within the current City workforce. Consultants will provide short-term technical expertise and capacity for this highly integrated effort. They provide specialized expertise that is not feasible to maintain permanently within the City's workforce, given the temporary and cyclical nature of capital projects.

Consultant services are temporary and limited to the capital project duration. When construction and commissioning are complete, all documentation, models, and training will be transferred to the Airport's operations and maintenance staff to ensure long-term ownership and continuity. Airport stakeholders are engaged throughout the duration of the project to ensure a smooth turnover at completion.

Attachment B – TIMELINE OF PSC REVIEW

The following list outlines the sequence of events related to the review of DHRPSC0005350 Airport Security Infrastructure Program Phase 2 Project for Project Delivery Partners and Design-Build services:

- October 23, 2025: The Airport submits additional requested information to the Commission to calendar the item for its November 3rd meeting (this document).
- **September 15, 2025**: Civil Service Commission Meeting: DHRPSC0005350 Airport Security Infrastructure Program Phase 2 was approved, subject to additional information being provided.
- August 27, 2025: As a follow-up to the meeting with the IFPTE Local 21 (Union) on August 7, 2025, the Airport provided additional information as requested.
- August 7, 2025: A virtual meeting was held between the Airport's Chief Development Officer and Director of Project Management, and the Union to discuss objections and next steps.
- **July 29, 2025**: The Airport requested a meeting to respond to the questions and move forward to prevent further delays.
- June 18, 2025: Union submitted six additional questions.
- **April–July 2025:** Multiple reschedules requested by the Union, along with pre-meeting information demands, delayed PSC advancement.
- May 27, 2025: A meeting between the Union and the Airport was scheduled at the Airport. Union did not attend.
- May 1, 2025: The Union objected to PSC DHRPSC0005350.
- April 17, 2025: The Airport submitted PSC DHRPSC0005350 to DHR and the Commission.
- April 16, 2025: No responses were received to the Notice of Intent (NOI).
- March 26, 2025: A NOI was sent to all City Departments, notifying them of the Airport's
 intent to procure services for Project Delivery Partners and inviting expressions of interest
 or availability to perform any or all of the work. See Attachment C.

PROJECT BACKGROUND:

The ASIP Phase II Project ("Project") will involve project management, design and construction of a new security system and upgrades to existing infrastructure. The Project is mainly a continuation of ASIP Phase I, which migrated and expanded the closed caption television (CCTV) camera system. The Airport aims to improve security and operational efficiency through the installation of new CCTV cameras, implementation of a robust conduit network, and the integration of systems. Camera coverage will be increased in areas of known deficiency airport-wide to enhance surveillance and response capabilities. This project is a critical step in modernizing airport security and ensuring compliance with the latest industry standards.

SUMMARY OF SERVICES REQUESTED:

The contractors will provide project management support and design-build services that include overall management expertise and oversight of the Project, design management and construction management services, project controls, contract administration, cost estimating services, field inspection, commissioning services, and a camera control system specialist.
