Introduction

The San Francisco Human Services Agency seeks an emergency retroactive approval for DHRPSC0005867, for an emergency contract starting October 30, 2025, through December 31, 2025. This contract is essential to provide food access to approximately 112,000 San Franciscans who will lose their CalFresh benefits as of this Saturday, November 1, 2025, unless the federal government provides funding. On October 29, 2025, Per Section 21.15 of the San Francisco Administrative Code, the President of the Human Services Commission approved an emergency contract these services.

Background

Due to the ongoing federal government shudown, funding for the Supplemental Nutrition Assistance Program (SNAP) is set to lapse on November 1, 2025. This will cause 112,000 San Franciscans living in 82,000 households to lose access to food assistance. In response, San Francisco is working to put in place an emergency stopgap program to provide food assistance dollars to these residents.

Justification for Contracting

This agreement supports the process of secure disbursement of stopgap benefits for CalFresh eligible households that will not receive benefits due to the Federal shutdown. The regular system for disbursing benefits is not available to us because of the shutdown. The City and the Crankstart Foundation have partnered to fund ~\$18 million of benefits in November. Through this agreement with the contractor, we are gaining access to a system to facilitate the distribution of these benefits. GiveCard's platform and technology infrastructure is ready and capable of rapidly disbursing millions of dollars to eligible recipients. Their system has a proven track record of delivering rapid response emergency aid (including the recent Texas floods and LA wildfires). The City has no existing mechanism to distribute funds with comparable speed or relative accessibility for our clients outside of the State/Federal platforms, which are unavailable for this purpose due to the shutdown. The dollars in the agreement are supporting the benefits themselves. This short-term stopgap program has been developed to handle a one-month surge in need. Work that can be done by City staff (e.g., generating and mailing 82,000 letters to CalFresh-eligible households, call center support, as-needed onsite distribution) is being done by City staff.

Additionally, this is a short-term contract with a duration of 2 months. The services will be terminated upon the resolution of this situation.

Union Notification

On October 30, 2025, SFHSA notified SEIU 1021 of the emergency contract and formally requested a waiver of the standard review period. The request was approved by Oumar Fall, SEIU Local 1021's San Francisco Field Director.

Consequences of Denial

The USDA Food and Nutrition Service has indicated that SNAP (CalFresh in California) benefits will not be issued on November 1. In San Francisco, these benefits provide food support for 112,000 low-income people living in

82,000 households. In a normal month, eligible San Franciscans receive ~\$20 million in food support from this program. This stoppage will be devastating for these individuals and families who are living in poverty and rely on these benefits to meet daily nutritional needs; many will be forced to choose between putting food on the table and paying rent or meeting other essential needs. Without these benefits, food insecurity in San Francisco will rise quickly and steeply. This short-term stopgap program is being put in place to avoid the worst impacts of this loss of federal safety net benefits.

Conculsion

In conclusion, we recommend that the Civil Service Commission retroactively approve PSC DHRPSC0005867 to address this emergency.

In addition, the contractor is a widely known and trusted nonprofit community food support partner - with credibly in San Francisco's immigrant communities, many whom are fearful of government at this time. Having them as our partner builds credibly and legitimacy.

Subject: Authorization for One-time Emergency Supplemental SNAP Aid

The City and County of San Francisco seeks the consent of the Civil Service Commission to authorize and expedite its partnership with the Crankstart Foundation, GiveCard, and the San Francisco-Marin Food Bank to distribute emergency food-assistance to San Francisco residents that will miss Supplemental Nutrition Assistance Program (SNAP) – known in California as CalFresh – benefits due to the federal government shutdown and failure to fund this essential benefit.

Background

Per Governor Gavin Newsom's October 20, 2025, press release, the continued federal shutdown will delay CalFresh benefits for the month of November. "The federal government has directed states to hold November 2025 benefit data that would normally allow CalFresh funds to be allocated to persons with CalFresh benefit cards."

In San Francisco, approximately 112,000 residents in 82,000 household rely on CalFresh benefits. With the federal funding lapse beginning November 1, 2025, these households face an imminent loss of vital food assistance. In response, the City and County of San Francisco, with unanimous support form the Board of Supervisors, has launched an emergency \$18 million public-private relief initiative to ensure that these households do not go without food in November.

Request

The City and County of San Francisco requests emergency approval of Personal Service Contract DHRPSC0005867 from the Civil Service Commission that will enable its partnership to immediately support vulnerable San Francisco residents.
