October 2025 RPD TIDA Landscape Report

Month Overview:

Brandon and Joseph attended the bi-weekly field tours with TIDA, Rubicon and SF Environment Department. Areas of discussion began with Panorama Park and the Ceanothus plantings and the barrier stakes. We also discussed Cityside Park and some irrigation concerns on the lawn and the Eucalyptus trees moving forward. We also talked about the identifying failing plants and the replacement of those plants. We spoke about Signal Point and reviewed areas for best maintenance practices. We reviewed the new plantings along the Signal road as well. Lastly, SFRPD's Natural Resource Division has continued to review the natural areas of YBI.

Panorama Park

- We are continuing to monitor the Ceanothus. If the conditions do not improve, there are plans for replacements. Rubicon is also adjusting the irrigation according to need. We continue to monitor the staking.
- The Dymondia is filling in nicely. The transplants have rooted and have really filled in the blank spaces.
- Panorama lawn is still looking good and is appropriate for this time of year.

Cityside Park

- Reviewed lawn discoloration, Rubicon in middle of coverage testing at the time, Sergio to report findings to group/Magda/Joey. We had discussed the spacing of the irrigation heads and making sure we had matched precipitation rates amongst the heads. The spacing seemed far considering the windy conditions. We would have preferred head-to-head coverage.
- Rubicon has been flagging plants newly performing poorly/dead as they find them since TIDA acceptance/park opening.
- The Eucalyptus look well and seem to be adapting. There is a plan to review and develop a long-term care program.

Signal Point

- The Catalina Cherry Trees are being monitored. The progress is slow and will not see results until next Spring. We will continue to monitor.
- Reviewed the installed Madrones along Signal Road and in the roundabout. Rubicon arborist to review/report on condition of the one obviously unhealthy tree at roundabout. TIDA/SFE/Rubicon will continue to monitor the Madrones along Signal Road through winter.
- We noticed signs of weed whipping damage to the trunks of some of the Madrones. Rubicon will make adjustments to manually maintain these areas to avoid further injury. Reviewed water runoff and the soil conditions and steep slope contribute to runoff and it is not a leak.

Trial Planting Areas

The location has been identified. Suitable test species have been narrowed down. Need to design and tie in irrigation to be able to support the area.

Natural Areas

Carol Sionkowski, Christopher Campbell, Peter S, and Peter B continued to meet to discuss, review, and learn about the Natural Areas on YBI. They had their final walk through/tour and next steps are to review the materials and come up with a defined maintenance plan with RPD
