Can you use the Non-Citizen Voter Registration Form to register to vote in the Board of Education election on November 3, 2026?

ALL of the statements below must be true:

- ☐ I am not a United States citizen
- ☐ I live in San Francisco
- ☐ I do not plan to move before November 3, 2026
- ☐ I am the parent, legal guardian, or caregiver* of a child who lives in San Francisco and will be under 19 years old on November 3, 2026
- ☐ I will be at least 18 years old on November 3, 2026
- ☐ I am not in prison for a felony
- ☐ I have not been found mentally incompetent to vote by a court

*A caregiver is someone who signs the affidavit to enroll a minor in school and consents to school-related medical care on behalf of the minor. This is determined by state law, in CA Family Code §6550-6552.

Registering to vote with the Non-Citizen Voter Registration Form does not permit you to vote in any other federal, state, or local elections.

2. In **Section B**, affirm under penalty of perjury that you are eligible to vote in the Board of Education election and that all information is true and correct. Sign and date.
3. **Return this form to the Department of Elections.** To return by mail, fold the form to connect the red triangles on the left, and then connect the blue dots. Use tape to seal. To return in person, visit the Department's office in City Hall, Room 48.

Once the form is processed, the Department will mail you a Notification Letter to confirm your registration. If you do not receive the letter within a week, call (415) 558-6100.

All registered voters in San Francisco will be mailed ballots for the November 3 election. In-person voting services will also be available at the voting center and polling places. For information, visit sfelections.gov/NCV.

A Eligibility Requirements: I am not a United States citizen; I live in San Francisco; I do not plan to move before November 3, 2026; I will be at least 18 years old on November 3, 2026; I am the parent, legal guardian, or legally recognized caregiver of a child who currently lives in San Francisco and will be under the age of 19 on Election Day, November 3, 2026; I am not in state or federal prison for a felony; I have not been found mentally incompetent to vote by a court.
