THE CENTERS FOR MEDICARE AND MEDICAID SERVICES (CMS) TERMINATED LHH'S PARTICIPATION IN THE MEDICARE AND MEDICAID PROVIDER PARTICIPATION PROGRAMS IN APRIL 2022. AS A RESULT OF A SETTLEMENT AGREEMENT BETWEEN CMS, THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH, AND LHH AS OF NOVEMBER 9, 2022, LHH WILL BE REQUIRED BY CMS TO TRANSFER OR DISCHARGE PATIENTS STARTING FEBRUARY 2, 2023, WHILE APPLYING FOR RECERTIFICATION TO THE MEDICARE AND MEDICAID PROVIDER PARTICIPATION PROGRAMS.
