7. Surveillance Technology Policy Review: Temporary ID and Contact Tracing System (Action Item)

Marc Upchurch presented on behalf of the Department of Public Health on their Temporary Visitor Registration, ID & Tracking System Policy.

Questions posed by members of the subcommittee include:

- If a visitor comes in without an ID, will they not be able to see the patient?
- Is this ID verification practice currently enforced?
- Who maintains the watchlist database?
- What would be required for the department to provide law enforcement information, such as who visited a patient?
- Is the data on-premises, and does the vendor have access to this data?

Suggestions from members of the subcommittee include:

- Under the section labeled Internal Data Sharing, include the template language for engagement with law enforcement
- Under the section labeled Benefits, be more explicit about increased safety for staff and visitors
