Regular Meeting

1. Call to Order and Roll Call

The Redistricting Task Force met in regular session through videoconferencing, and provided public comment through teleconferencing, on Wednesday, February 9, 2022. Chair Reverend Arnold Townsend called the meeting to order at 5:40 p.m.

On the call of the roll, Chair Townsend, Member Jeremy Lee, Member Hernández Gil, Member Pierce, Member Castillon, Member Ho, Member Cooper, Member Chasel Lee, and Member Reiner were noted present. A quorum was present.

2. District 8 Boundaries, Neighborhoods and Communities of Interest

Speakers: Manny Yekutieli; requested that the Task Force recognize the merchants and businesses of the Valencia corridor as a community of interest, move the boundary between Districts 8 and 9 eastward, and include the Valencia merchant corridor in District 8.

Jonah Buffa, President (Valencia Corridor Merchants Association); requested that the Task Force recognize the merchants and businesses of the Valencia corridor as a community of interest, move the boundary between Districts 8 and 9 eastward, and include the Valencia merchant corridor in District 8.

David White (Valencia Corridor Merchants Association); requested that the Task Force recognize the merchants and businesses of the Valencia corridor as a community of interest, move the boundary between Districts 8 and 9 eastward, and include the Valencia merchant corridor in District 8.

Tyler MacNiven, West of Pecos Restaurant (Valencia Corridor Merchants Association); requested that the Task Force recognize the merchants and businesses of the Valencia corridor as a community of interest, move the boundary between Districts 8 and 9 eastward, and include the Valencia merchant corridor in District 8.

Chris Faust (Upper Noe Neighbors); requested that the Task Force retain the current boundaries around the Upper Noe neighborhood along San Jose avenue to Cesar Chaves Avenue.

Hilary Schiraldi, President (Glen Park Association); requested that the Task Force retain Glen Park in District 8.

Aisling Ferguson; requested that the Task Force include both sides of the Valencia corridor in District 8.

Jordan Wing; requested that the Task Force unify the Mission and Valencia corridors in one supervisorial district.

Milo Trauss; requested that the Task Force retain Noe Valley with Glen Park and Diamond Heights in one supervisorial district.

Carolyn Kenady (Dolores Heights Improvement Club); requested that the Task Force retain Eureka Valley, Corbet Heights, Diamond Heights, and parts of the Castro together in one supervisorial district, and recommended that the Valencia Corridor be retained wholly in one District 8

David Pilpel; requested that the Task Force review the boundaries he submitted on file, which includes all of the UCSF Parnassus campus in District 8, and moves the Valencia Street merchant corridor into District 9 by making Bartlett or Mission Streets as the border rather than Valencia Street.

Steven Depont-Kelani Currier; requested that the Task Force consider changes between the border between Districts 8 and 11, and requests that residents living nearby to Glen Park BART be moved into District 11.

Luke Bornheimer; requested that the Task Force move the border between Districts 8 and 9 eastward to the alleyways, rather than to a major street such as Mission, thereby avoiding making another merchant corridor split between two supervisorial districts, and encouraged a proportional splitting of city parks which are bordered by multiple supervisorial districts.

At the conclusion of the discussion, Chair Townsend declared the matter heard and filed.

2. District 1 Boundaries, Neighborhoods and Communities of Interest

Bethany; requested that the Task Force adjust the northern border to include both sides of Lake Street and the Seacliff neighborhood in District 1.

Richard Rothman; requested that the Task Force not adjust the northern boundary of District 1, and retain the boundary at Lake Street.

Jane Natoli; requested that the Task Force adjust the northern border to include both sides of Lake Street and the Seacliff neighborhood in District 1.

Grant Ingram; requested that the Task Force adjust the northern border to include both sides of Lake Street and the Seacliff neighborhood in District 1.

Alexander Stein; shared various concerns with the Task Force.
