

### **Project Description**

The project would convert up to 213,400 square feet of gross floor area at the existing five-story building from wholesale sales to office use. The project site was converted to office use in the 1990s without benefit of Planning Department approval and has maintained office use since that time. The project would legalize the longstanding office uses at the project site.

#### Determination

The City and County of San Francisco decided to carry out or approve the project on May 19, 2025, when the Planning Department issued the Planning Approval Letter. A copy of the document may be examined
