Commissioner comments:

Herbert: This was a really great format, and very inspiring.

Ortiz-Cartagena: SFMTA needs to come present. So many of the challenges – foot traffic, quality of life, big events, are often out of small business' hands.

Benitez: We need to use chains/formula retail resources into the community – they need to contribute.

Cornet: So many similarities in what we're all experiencing.

Zouzounis: This gives us so many concrete things to follow up on – capacity building and business to business assistance.

Huie: This is great feedback for our Commission to revisit, highlight, and amplify. We can also use the OSB newsletter to help engage merchants. There's content for a merchant toolkit to share what's worked, etc. It's worth highlighting how the Mayor's Permit SF legislation which we'll hear next may support some of the challenges we talked about. I know it's so hard to run a merchant group as well as your own business so it's important to support each other.

Director Tang provided an overview of the Mayor's Permit SF package which will address some ongoing challenges OSB and caseworkers have identified through helping clients. This includes removing excessive permitting requirements, reducing unnecessary Department referrals, and allowing security gates into the Amnesty Program to help additional businesses address complaints.

Zouzounis: for conditional use authorizations, do you have to request the CB3P process, or can you get it automatically? It should be flagged at the Planning counter.

Ortiz-Cartagena: If Calle 24 opts out of CB3P, those businesses can't get expedited processing? Correct. They will not have a guaranteed timely hearing at the planning commission.
