Background

- **The Commission Streamlining Task Force was established by November 2024's Proposition E**
 - Purpose: make recommendations to the Mayor and Board of Supervisors about ways to modify, eliminate, or combine the City's boards and commissions to improve the administration of City government
- **Deadlines**
 - Feb 1, 2026: approve final report with recommendations
 - Mar 1, 2026: approve legislation (charter amendment and ordinances)
 - Apr 1, 2026: Board of Supervisors must hold a hearing on the recommendations
