1. Call to Order & Roll Call

President Parker called the meeting to order at 6:13 PM.

2. General Public Comment

3. Approval of previous meeting minutes

May meeting minutes were approved by general consensus. There were no public commenters.

4. Director's Report

Director Arntz presented his monthly September 2025 report. Topics and discussion with Commissioners included updates regarding the September 16 Special Recall Election and the November 2025 Statewide Special Election. Director Arntz shared details about post-election processes, including filling a vacancy. The Board of Supervisor will have an agenda item to declare results after the election is certified, then the mayor has 10 days to either

sign, veto or take no action on their resolution. This is when the vacancy for D4 Supervisor would occur. The election to fill the D4 vacancy would take place June 2026 and the nomination period would begin in December 2025. The election for the regular full term D4 seat will take place in November 2026.

The department plans to consolidate polling places for the November 2025 election. Notification regarding polling places is on the website and the voter's pamphlet. Overseas ballots (approximately 12,000) to be sent on September 20, 2026.

Outreach efforts will continue at previous levels despite reduced polling places for the upcoming election. Accessibility information is shared through partnerships with organizations serving individuals with disabilities

Public Comment:

David Pipel (online) expressed his appreciation to Director Arntz and staff for their work on the special recall election, which I think went very smoothly. He also expressed appreciation for the November election plan.
