Streamlining Task Force

Regarding the four (4) attachments know that I sent them immediately after the library's internet link was broken. (See four (4) Attachments)

Also know that the library leadership sent another library staffer to a June 2, 2025 Sunshine meeting to intentionally misrepresent in that meeting that in fact the library had given me all requested documents - when they had not.

Moving forward as I continued to seek the record the library took a opportunities possible to demean me or to degrade my experience because I continued obtain the document which served as the basis of a fraudulent action against me.

The library's most flagrant display occurred earlier this month when a seemingly planned blocking of my attempt to share policy concerns with a third library commissioner. (See #1 Attachment)

The purpose of this and other information is to have the Streamlining Task Force take seriously what those in the library management and leadership realm are doing. Several months ago the task force's vice-chair replied to me, " ...it must be frustrating", when responding to me sharing a sampling or the poor if not criminal library conduct. And the chair has not yet responded to an email I put before him for several months now.

A decision far more impactful than simply keeping the San Francisco Library Commission is due the people of San Francisco. Greetings Ms. Coolbrith,

Thank you for the letter you sent to me dates 10Dec24 re my two formal records requests submitted on 9Dec24. I obtained your letter on 18Dec24 then received a letter from the Mayors office re same two formal records requests on 24Dec24.

The mayors office forwarded my requests but did not state when this had been done.

The problem is that the latter letter was sent when the records were scheduled to be due to me. Now, requested records are past due.

I am willing to overlook this delay, if I am able to meet and exchange views with whom ever it would be appropriate to do so with re 1) the abrupt broken enforcement link of an eight (8) page document that was broken after city working hours; and 2) other troubling aspects of my 4Dec24 Mission Bay library encounter.

Please forward this email to the person that will be able and willing to arrange for this meeting next week.

Since this will be my sixth (6th) attempt to establish inroad communications with library leadership, I ask that a time be set during the first two (2) days of next week, before the end of this calendar year. My last failed attempt to meet and exchange views was on 19Dec24 during the last Library Commission Meeting as I waited to be recognized as a remote speaker.

Again, the library enforcement matrix link was broken during off work hours prior to the start of the next business day by 0700hrs, surely a meeting could be arranged for me to meet and exchange views with a half day's lead time.

Finally, I have also included Library Commission staffer Ms. Schaub on this time sensitive email. I look forward to hearing good news re a meeting.

AUG&SEP LIBRARY COMMISSION MEETINGS BACKGROUND & REQUEST

Just prior to last month's Library Commission meeting while standing next to the stage area where Commissioners Lomax-Ghirarduzzi and Commissioner Huang (C Huang) were talking. I saw Commissioners Lomax-Ghirarduzzi in the hallway prior to the meeting auditoriums opening and she told me that she would alert C Huang that I needed to speak with him. When I entered the space Ms. Lomax-Ghirarduzzi were speaking with Mr. Huang with her back to the audience while he was looking in my general direction. This mistake would be learned and not repeated during the following months meeting.

Mr. Lambert came over to where I was standing by the edge of the stage attempting to gain C Huang's attention. He alerted me of the meetings approaching start so I let him know that I would sit in the front row as soon as the call to order was made. He agreed then walked away. Ms. Shaub asked me to not disrupt the meeting, I asked her to relax, then she reminded me, "...this is my space and you don't tell me what to do!". I replied, "No, this is our space, and you don't tell me what to do". Mr. Huang and I spoke briefly and gave him my email address. Before we parted Mr. Huang told me that he needed to first speak with Mr. Lambert before responding to me. I warned C Huang that doing so might not be productive for me as library staff involvement at this point has not been useful. The meeting started we parted quickly. I stayed some time before leaving feeling assured after having made contact with C Huang. This too was a mistake that was learned and would not repeat itself during the following months meeting.

Just prior to this month's meeting I checked the email address given to C Huang and no response from C Huang was in the inbox. I attended the Library Commission meeting where I addressed, during an opportunity to speak, the result of the "permission" C Huang sought from Mr. Lambert. I mentioned that I would still like to speak with C Huang but he said nothing. I looked to Mr. Lambert seeking any feedback re the permission exchange between himself and Mr. Huang that prevented me from being contacted. No response from Mr. Lambert was forthcoming.

Immediately after this month's meetings adjournment I assumed the same position next to the stage area where I got the attention of C Huang the month before, but this time I never made contact with C Huang even though I was calling out to him. C Huang typically exits out of the left door after adjournment but this time I took the stage position before he fully stood. Seemingly stuck on stage C Huang was motionless looking directly at Commissioner Bolander (C Bolander) where both stood speaking to each other at several feet apart. I observed C Bolander motioned simultaneously with his raised eyebrows and head motion pointing in my direction signaling my presence. C Huang formed a look of helplessness on his face.

Commissioner Huang never looked to his right where I stood. Mr. Lambert called out to me, I looked to my right then walked over to the edge of the stage where he stood reaching out to hand me his business card. He explained that he was willing to serve as an intermediary between C Huang and myself. I shared that my inquiry was policy

directed, thus justifying me reason for follow up with C Huang but Mr. Lambert did not rescind his offer to act as a go between. Mr. Lamberts imposition suggests that a library policy or other exists that may explain what happened when C Huang and Mr. Lambert spoke about my exchange with C. Huang last month.

Mr. Lambert walked away to the back of the stage so I refocused my attention back to C Huang who was now slowly moving towards Mr. Lambert. Ms. Maureen walked towards where I was standing then quickly a library staff person who had made a presentation on a library prison program was standing next to me. I asked the person if I could ask Ms. Maureen a question, the person did not respond but Ms. Maureen responded in a way that let me know that I would not be acknowledged. Then both of them stood on the stage with their backs to me.

I observed Mr. Lambert with his back to me and by this time extending his left arm out towards C Huang in a fashion resembling an usher. Before I knew it C Huang and Mr. Lambert moved quickly through the door located on the right of the stage, when looking at the stage from the audience. I walked across the front of the stage and up towards the back of the auditorium heading for the street level to ask security where the stage exit led to. While in motion but still in the auditorium C Bolander happened to be nearby so while passing him I said so that he could hear, "... it appeared that a game was being played with me" (a game whose goal was to prevent me from sharing my policy views with C Huang no doubt, and that both commissioners and staff were in agreement with the effort to block my follow up attempt to speak with C Huang).

The following records requests seek to continue my goal of communicating library policy matters to library commissioner whose role it is to specifically address library policy.

#2 Immediate Disclosure Request (Sent 21SEP25)

Please consider this a California Public Records Act request and a Sunshine Ordinance request for records known to be in the City and County of San Francisco's possession.

- 1) Please disclose any pertinent and specific records only that show, explain or in any way demonstrate where a San Francisco Library Commissioner must or shall first obtain approval from or first consult with the San Francisco Library Director prior to the commissioner responding to a request to speak with said commissioner; and
- 2) Please disclose all emails for all commissioners used by the library to share library related material, agenda, and other library related communications with commissioners; and

Please contact me for any needed clarity.
