Dear Chair Harrington,

The Building Safety Alliance opposes making the Building Inspection Commission advisory only and eliminating the Code Advisory Committee. These bodies were established to promote transparency and to allow public input into inspections and proposed regulations.

Losing these bodies will slow down permitting, create confusion, and threaten public safety.

Before the BIC was created, building code enforcement was handled by the Bureau of Building Inspection as part of the Department of Public Works and did not involve public input.

Public dissatisfaction with this system's responsiveness led to the formation of the current BIC.

- Changing the Building Inspection Commission (BIC) from an oversight to an advisory body will not simplify
 government. It could create a situation in which public safety policy decisions are made in private, without public
 input or accountable transparency.
- The Code Advisory Committee (CAC) to the Building Inspection Commission is an effective public body, with highly trained, specialized experts in construction, maintenance, and systems such as electrical, mechanical, and plumbing. It provides valuable real-world input on proposed regulations that improve the permitting process and safety for residents and businesses across San Francisco.
- The CAC reviews local building code amendments to ensure they comply with the next cycle of the California Building Code, protecting people and property in San Francisco. It also reviews all proposed ordinances impacting the Building Codes.
- The CAC operates as a public body with open meetings, public input, and published minutes to ensure transparency and efficiency in all of their work as a commission.

Replacing the current open meeting system with a passive one will limit public input opportunities. It could also increase pressure on the Department of Building Inspection staff and Commissioners from those seeking to weaken building codes designed to protect residents and property in San Francisco.

Any issues at the BIC were due to individuals and leadership, **not** because of the commission structure. Making the BIC advisory only and eliminating the CAC will reduce transparency into building inspections and safety in San Francisco. It will create confusion and push more work to already understaffed departments that could slow down an already historically long and difficult to navigate permitting process in San Francisco.
