### **3. Super Bowl 2026 Update (Discussion Item)**

Adam Lewis, Bay Area Host Committee, discussed the Bay Area Host Committee efforts to engage small businesses in preparation for Super Bowl 2026. Goal of host committee is to drive economic/cultural/social impact. Small Business Source: developing a local supplier tool for future events. Produced a public screening playbook with guidelines for small businesses to participate in Super Bowl events.

Commissioner comments:

Huie: is the local suppliers guide available? Not yet

Ortiz-Cartagena: thanks for all of this work

Herbert: How long has the host committee operated? 2 years

Zouzounis: Will you help with wayfinding/maps to help direct people? Yes.

**4. BOS File 251251 – Tenderloin and South of Market Retail Hours Restriction Pilot Program (Discussion and Action Item)**

Bryan Dahl, Legislative Aide to Supervisor Dorsey presented an Ordinance amending the Police Code to expand the current Tenderloin retail hours restriction pilot program, under which retail food and tobacco establishments in the restricted area are prohibited from being open to the public from 12:00 a.m. to 5:00 a.m., or from 2:00 a.m. to 5:00 a.m. if subject to regulation by the California Department of Alcoholic Beverage Control, to encompass a high-crime area across the Tenderloin and South of Market neighborhoods; and to extend the duration of the pilot program, currently set to expire in July 2026, to instead expire 18 months from the effective date of this Ordinance.

No members of the public requested to speak.

Huie: Where is the illegal activity going – is being pushed elsewhere? Bryan wasn't aware. The focus of the legislation is to prevent gathering at night. This would sunset in 18 months.

Huie: What other efforts are you pursuing to address this? We've been working to get additional beat officers.

Cornet: is there data from the DMACC operations on the impacts of the pilot? Yes, data shows a 56% decrease in large gatherings.

Zouzounis: Prior to COVID, SBC looked at fee justice, removing outdated codes, etc. Now we're seeing a focus on legislation for rich people. There are significant food access concerns in these neighborhoods. The two main solutions merchants have been offered alongside this proposal are land use changes and increased police staffing. This vilifies a certain demographic of businesses. There needs to be carrots along with sticks.

Bryan: We want longlasting solutions. OEWD will help with outreach.

Herbert: When these businesses close, where will people go? We've seen a 13% decline in narcotics/late night night violent crime and 18% decline in calls for service between 12-5am in the pilot.

Zouzounis: SBC can play a role by requesting new mitigation measures- better refrigeration upgrades to help businesses meet upcoming energy requirements.

Motion to support legislation and to explore/identify long terms solutions ot equity concerns and consider long term mitigation efforts.

**5. BOS File 260025 - Acceptance of Cash by Brick-and-Mortar Businesses (Discussion and Action Item)**

Melanie Mathewson, Legislative Aide to President Mandelman, presented on an Ordinance amending the Police Code to delete Article 55 and thereby repeal the requirement that brick-and-mortar businesses accept cash for the purchase of goods and services other than professional services.

Ortiz-Cartagena: I asked my community about this proposal and in the Mission businesses said as long as they had the choice to accept cash if they want, they were fine with it.

Herbert: My business in Oakland went cashless and we didn't experience any more break ins after.
