3. Beyond the Front Door Update (Discussion Item)

Eli Gelardin, Director, Office on Disability and Accessibility, Debby Kaplan, Office on Disability and Accessibility, Stephen Kwok, Department of Building Inspection, and Michelle Reynolds, Office of Small Business presented on resources developed through the Beyond the Front Door initiative to help small businesses learn best practices for accessibility. They discussed the recent Accessible Business Entrance program which sunset and then was the impetus for the working group. Resources like this will help build relationships between the disability community and small businesses.

Public comment: Jorge Aguello, small business owner

Commissioner comment:

Dickerson: Appreciates the approach this group has taken. Had questions regarding accessibility requirements for her new space; Stephen explained that depending on how much construction is done, she may need to bring it up to code.

Herbert: Met Alicia Contreras recently and talked about hearing impaired community.

Huie: How does SF measure up to other cities in terms of accessibility? Director Gelardin explained it's ahead of the curve in part because of thoughtful partnerships like this. Debby emphasized it's important to rebuild trust between small businesses and disability community because litigation regarding accessibility hurt the relationship.

Huie: What's the outreach plan? Newsletters, social media posts, direct outreach to businesses surrounding upcoming conference for people who are deaf and hard of hearing. They'd also like to highlight businesses that are doing a good job.

Cornet: This is a great step and stories will be helpful.

Benitez: Really helpful tool. What about internet accessibility? Director Tang explained the challenges and that OSB has moved Shop Dine SF to sf.gov to accommodate.

4. Letter Opposing Commission Streamlining Task Force Recommendations for Small Business Commission (Discussion and Action Item)

President Huie presented a letter to the Board of Supervisors opposing the Commission Streamlining Task Force recommendations for the Small Business Commission. She explained that the Commission offers small businesses a role and allows them to give input in a way that previously wasn't possible.

Dickerson: Vice President Ortiz-Cartagena has been mentioning this and I don't think we should change a well functioning commission.

Herbert: We play an important advocacy role.

Benitez: Agrees with the letter.

Cornet: SBC shouldn't be changed.

Legislation to create a permit program for flower stands will be at the Board for a final vote tomorrow.

Permit SF announcements will also be coming tomorrow.

Commissioner comments:

Huie: Does this mean hookah lounges will be allowed? No because that's flavored tobacco.

Cornet: Wanted clarity on who can enforce on unpermitted sales: DPW can enforce street vending but SFPD can get involved if it's the sale of certain commonly stolen goods.

8. Commissioner Discussion and New Business (Discussion Item)

Huie: Went to the Babylon Burning anniversary. Also participated in Ladysmith SF wrap up of female entrepreneurs.

Cornet: Roosters Peru in the Mission is always busy. Wanted to know if Rosamunde's can become a legacy business.

Cornet: would be great to highlight businesses that offer childrens classes for summer.

Dickerson: this will be her last meeting; going to pursue a bigger space and build her business.
