Re: **Additional Edits to Streamlining Task Force's Final Report**

Dear Chair Harrington and Commission Streamlining Task Force,

I believe this Task Force should consider making these suggested edits to the next iteration of your draft "*Final Report*."

- On page 40 in the second draft of the "*Final Report*" presented on January 14 there appears to be an incomplete sentence in the "***Special Strike Committee***" paragraph. The sentence currently reads: "*In addition to eliminating this body, the Task Force **would** a broader Charter amendment to repeal Section AB.345 in its entirety ...*"

A word appears to be missing following the word "**would**."

This incomplete sentence was included in the first draft of the "*Final Report*," but it was not corrected the the second draft (version #2).

- In the main document of the "*Final Report*," I recommend that you add a new, additional "*Appendix 'E'*" **before** the current "*Appendix E*" ("*Record of Task Force Votes*") to include the **BLA's full report**, including the BLA's "*Appendix 4*" (the alphabetical list of "**Board and Commission Costs**"), since both documents were a key feature of "*Proposition E*" that mandated the BLA conduct a financial analysis as a key deliverable [§4.100.1(c)]. Because it was a mandated feature of "*Prop. E*," this Streamlining Task Force has a duty to include it in the main document of your "*Final Report*." San Franciscan's deserve to have this taxpayer funded report available and easily accessible in your Final Report.
- In the main document of the "*Final Report*," I recommend that you add a second new, additional "*Appendix 'F'*" **before** the current "*Appendix E*" ("*Record of Task Force Votes*") to include the final version of your "**Decision Log**" for future readers of this report to easily access. I suggest it be included in the main document of the final report as an appendix, and that it not be added to the "*Supplemental Appendices*" document.
- Then in the main document, rename the current "*Appendix E*" to be "*Appendix G*."
- In the "*Supplemental Appendices*" document, renumber the current Appendices "*F*," "*G*," and "*H*" to be Appendices "*H*," "*I*," and "*J*."
- In the "*Supplemental Appendices*" document, at a minimum, on the first page of the document you should add a cross-reference listing the page numbers, for readers' convenience, since it is a 1,000-plus page document.

In addition, add searchable Title Page "***fly sheets***" just before the start of each Appendix of the report to demark where one Appendix ends and the next Appendix begins.
