AB 767 (Gipson): Community Paramedicine or Triage to Alternate Destination Act **Recommended Position: Support** 

AB 767 would extend the sunset date of the community paramedicine program from January 1, 2024, to January 1, 2031. The bill also adds short-term, post-discharge follow-up for persons recently discharged from a hospital to the list of eligible community paramedicine services.

SB 244 (Eggman): Right to Repair Act **Recommended Position: Support** 

The Right to Repair Act would require manufacturers of consumer electronics and appliances to make their product repair manuals, diagnostic information, and components accessible to consumers and third-party service repair businesses in California.

AB 578 would update the monitoring fee that the California Department of Housing and Community Development (HCD) charges affordable housing developers, which could unlock over \$20 million dollars in private financing for desperately needed affordable housing, based on awards since 2018.
