We've Identified 149 Bodies That Are In-Scope for the Task Force

- Commissions are in-scope if they are:
 - Established in law, OR at the formal direction of some policy body, AND
 - Within the jurisdiction of the City and County of San Francisco
- Recommend excluding subcommittees comprised of members of the parent body
- Believe 34 bodies are currently inactive.
 Confirming with departments

113 :In-

In-scope and active

- In-scope for the Task Force and actively meeting
- The Task Force may wish to spend most of its time evaluating these bodies

34

In-scope but inactive

- In-scope for the Task Force but not actively meeting
- These may be strong candidates for elimination or consolidation

Already sunset

- These bodies have already sunset, but remain in code
- No action needed on the part of the Task Force. The City Attorney will remove these from code

*Identified an additional 32 bodies which are out-of-scope for the Task Force

25 Commissions Fulfill a State or Federal Legal Requirement

- Still researching a handful of bodies
- May be expressly required, or may serve some legally required function which could be carried out by another body

Future Decision: Combining or Eliminating Commissions

 If the Task Force wishes to combine a legally required commission with another body, the City Attorney must review the specifics and determine whether the proposed combination is legally permissible

Most Commissions Do Not Have Sunset Dates

- Just 14 out of 113 in-scope and active commissions have sunset dates (12%)
 - These are mostly coded as advisory bodies
 - Dates range from June 2026 January 2035
 - Several triggered by some action/event rather than a fixed date
- Board Rules of Order 2.21

Regular Meetings of Subordinate Bodies.

Whenever the Board creates or reauthorizes, by ordinance or resolution, a board, committee, task force, or other multi-member body, the Board shall include language requiring ... a sunset clause not to exceed three years...



Future Decision: Sunset Dates

- Does the Task Force want to establish sunset dates for some or all existing commissions?
- Does the Task Force want to require sunset dates for all new commissions going forward (e.g., by codifying in Charter/code that all new commissions must sunset after three years)?

Appointing Authority is Diffuse

- Most commissions have mixed appointments by multiple appointing authorities (68 of 113)
 - Some are solely appointed by the Mayor (24).
- Governance bodies (shown right) are mostly appointed by the Mayor (19 of 31) or by mixed appointing authorities (10)


Appointments to Governance Commissions



Most Commissions Have Seats With Special Qualifications

- 74 out of 113 in-scope and active commissions have at least one seat with special qualifications (65%)
- Next step: analysis of how special qualifications impact ability to fill vacant seats

Advisory Bodies Are Especially Likely to Have Special Qualifications, While Governance Bodies Are Least Likely



Future Decision: Seat Qualifications


- When should seats have special qualifications?

Commissions Span Many Policy Areas

- Governance and Advisory Bodies span across most policy areas
 - Both span across 20 different policy areas without a clear majority clustered into any one
- Most Regulatory bodies (69%) fall into three categories
 - General City Administration
 - Building and Permitting
 - Budget and Finance

Count of in-scope and active commissions by policy area



In-Scope Commissions

For purposes of this Section 4.100.1, an "appointive board" or "commission" includes any body that meets the definition of a "legislative body," under California Government Code § 54952, whether denominated a "board," "commission," "council," "committee," "task force," "advisory body," or otherwise.

- These include any commission created by charter, ordinance, resolution, or formal action of a legislative body (California Government Code § 54952)
- Working closely with City Attorney (CAT) to determine scope
- When filtering out inactive commissions, our list is nearly identical to CAT's November 2024 list, with only minor differences:
 - CAT included the Board of Supervisors
 - We include the Commission Streamlining Task Force, Law Library Board of Trustees, and Joint Zoo Committee
