It is not clear how the organization's leadership and decision making reflect, incorporate or center the communities most in need, particularly as described by the intended population for the Dream Keeper Initiative. It seems that the programming has been focused on Latinx and Spanish-speaking communities; while that is not inherently a problem nor does it mean that 18 Reasons could not expand their programming, this application does not clearly articulate how that expansion would happen.	13

33	18 Reasons provided a clear and concise description of their organization's mission, history, and track record. They effectively demonstrated alignment with the goals and priorities outlined in the RFP, particularly through their strong commitment to serving marginalized communities, with a specific focus on Black and Brown participants. The proposal included detailed examples of past programs that were culturally affirming and community-led, showcasing their ability to successfully serve historically marginalized populations. They also shared, in great detail, the experience, expertise, and lived experience of key staff members, highlighting their capacity to engage meaningfully and respectfully with the communities most impacted. Overall, all bullet points in this section were addressed thoroughly and effectively. 18 Reasons clearly demonstrated their commitment to cultural inclusion,			

community empowerment, and systemic equity, while centering community voices in both leadership and service delivery.

Cultural responsiveness was clearly embedded within the program model, as all staff and guest speakers reflect the cultural and linguistic backgrounds of the participants, helping to build trust and connection. 18 Reasons did a strong job detailing their outreach plan, with a clear emphasis on community-driven strategies. Their approach is rooted in existing relationships and trust within the community, as they receive referrals directly from partners who work closely with their target population. This helps ensure that those who could most benefit from the services is actively engaged. They also demonstrated a strong commitment to accessibility and inclusion by utilizing multilingual flyers, posters, and bilingual materials to reach non-English-speaking participants. Additionally, they addressed accessibility for individuals with disabilities by ensuring that all in-person spaces meet ADA requirements and by offering virtual participation options via Zoom. Overall, the outreach plan is culturally relevant, thoughtfully designed, and clearly aimed at fostering long-term relationships within historically underserved communities.

18 Reasons provided a detailed and thoughtful plan for tracking, measuring, 5 Points and reporting key performance metrics. They outlined their use of both qualitative and quantitative data, including pre- and post-program surveys, to measure changes in participants' cooking and eating habits, pregnancy outcomes, food insecurity levels, and the percentage of participants working with a doula. These metrics are well aligned with the program's goals and offer clear indicators of impact. To support data collection and management, they utilize Salesforce, a robust data tracking tool that enables efficient monitoring, reporting, and outcome analysis. The use of Salesforce strengthens their ability to ensure accuracy, consistency, and accountability across all program activities. In addition to internal tracking, they incorporate external evaluations to further assess program effectiveness and support continuous improvement. This added layer of evaluation demonstrates a commitment to objectivity and quality assurance. 18 Reasons also addressed how they will ensure transparency and accountability in reporting outcomes to the City, noting their intent to meet performance metrics as outlined in the RFP. Their use of regular data collection, Salesforce, and reporting tools supports compliance and demonstrates strong organizational capacity.

Both letters of recommendation were strong and effectively highlighted the intentionality behind 18 Reasons work. They spoke to the dedication of the staff, the organization's community-centered approach, and the meaningful impact they have made. The letters emphasized how 18 Reasons consistently uplifts and integrates the voices of the community they serve, taking a relational rather than transactional approach to program delivery and partnerships. Additionally, both letters reinforced the organization's cultural competency, organizational capacity, and commitment to engaging historically marginalized communities. Overall, the letters provided compelling endorsements of 18 Reasons effectiveness and deep-rooted presence within the community.
