Another significant gap is the lack of consideration for disability accommodations. Without clear strategies to support students with disabilities, the school risks excluding a portion of the community it intends to serve. Finally, there is limited evidence of how this agency fosters trust and builds authentic relationships with students and families. > While the school's intent is clear, there is a significant lack of planning around how student progress and program effectiveness are being tracked, measured, and reported. At this time, there is no evidence of a clear methodology or accountability system to capture key performance indicators such as student completion rates, percentage of successful versus unsuccessful students, or other outcome measures that reflect real impact.

Without data, it becomes difficult to evaluate whether the curriculum is truly effective. Equally concerning is the absence of student feedback mechanisms that could inform whether the learning experience is meaningful, accessible, and aligned with their needs. Student voice is a critical component in assessing the quality of curriculum delivery and the lack of it undermines the ability to make informed improvements. The agency must demonstrate not only what is being done, but also how well it is working. Without these measures this could cause a challenge 1 when delivering curriculum.

3 Points

While the partnership with CCSF is valuable, it highlights a limitation in the school's support network. Relying on a single partner does not demonstrate long-term sustainability or a robust pipeline of opportunities for students. It would be beneficial to see letters of support or commitments from four-year institutions that are willing to collaborate with this program. Such partnerships would strengthen the program's credibility, expand educational pathways for students, and show that higher education institutions are invested in their success beyond community college.

Description is high level. Could be more detailed and focused on the impact of how grant funding is proposed to 6 be used for technology enhancements.
