**SUBJECT:** Inactive Policy Bodies for Future Discussion and Vote

Per Proposition E, approved by voters in November 2024, the Commission Streamlining Task Force is responsible for making recommendations to the Mayor and Board of Supervisors about ways to modify, eliminate, or combine the City's appointive boards and commissions ("policy bodies") to improve the administration of government.

Through department outreach, **staff have identified 34 policy bodies which exist in code but are currently inactive.** These bodies are generally defined as those which have not met within the last year. However, there are some exceptions:

- Several policy bodies have met in the last year but should reasonably be considered inactive. These are listed as inactive, and a rationale is provided for each.
- Several policy bodies, such as the Elections Task Force, are only convened periodically for specific purposes. These are exempted from the one-year cutoff and are not included in the list of inactive bodies.

Today's memo establishes a list of inactive bodies. Between now and July 10, staff will engage with departments to develop recommendations about which inactive bodies should be eliminated from code. On July 11, staff will issue a recommendation memo to the Task Force, which may include recommendations to keep, eliminate, or defer decision-making on each of the 34 bodies listed below. No bodies will be evaluated beyond this initial list at this time. On July 16, the Task Force will vote on whether to eliminate inactive commissions and remove them from code.

If the Task Force recommends eliminating a body at the July 16 meeting, the City Attorney will prepare draft legislation removing it from code. The Task Force will then review the draft legislation at a future meeting and vote on whether to forward it to the Board of Supervisors.
