| 6. San Francisco-Marin food Bank<br>Updates, Noriko Lim-Tepper (SFMFB)<br>1:50 p.m. | Noriko Lim-Tepper provided updates on the San Francisco-Marin Food Bank (SFMFB). Overall the need and demand for their service continues to increase while funds and services are getting cut. SFMFB is in the process of phasing out Pop-Up Pantries by June 30, 2025, and reduced participants served through Pantry at Home by 48% in FY 22-23. SFMFB is transferring Pop-Up participants to other Pantries as space permits and will continue supporting and staffing the program up until June 2025. SFMFB is hoping to open Community Markets throughout San Francisco.  Follow up responses to questions asked during the meeting by task force members:  1. How many people/households are going to be impacted by the closure of the pop-up pantries (unduplicated)? | None.                    |

- a. To confirm around 13,000 households by the end of 2025 The numbers have been dropping steadily since FY23 with various actions we've had to take to limit participation. We've served an unduplicated 12K House Holds with 33K family members in SF through the pop-up pantry (PUP) program since January.
- 2. Other pantries will absorb participants impacted by closures, though not all participants will be able to get transferred to other pantries. What percentage or number of people will not be transferred?
  - a. We don't know how many PUP participants we will/won't be able to transfer. We are actively working to build capacity at partner pantries and community markets and are offering as many of those spots to PUP participants as we can. We currently have about 850 spots, some of which are in hard-to-reach locations like Treasure Island. It is also challenging transferring participants, some of whom are hard to reach and others who are unwilling or unable to transfer.
  - b. Are there specific demographics that will be prioritized for transferring? If so, which?
    - i. We will be offering PUP participants spots for transferring based on their proximity to pantries with capacity, not based on any demographic criteria.
- 3. What is the total existing waitlist?
  - a. We had to close the PUP program waitlist early in 2024 and that had about 4700 households who wanted, but weren't receiving groceries from Food Bank-supported programs. Our partner pantry programs have about 2400 households on their waiting lists.
- 4. What is the wait time to get off the waitlist?
  - c. Is there demographic specific data, such as how long a pregnant parent is waiting? We only collect contact information for people on waiting lists, so we don't have any demographic

Some pantries currently have capacity to take new enrollees/transfers and we are actively working to transfer PUP participants. Some pantries have long waiting lists and limited turnover, so some households have been on waiting lists since before Covid.  Maggie Shugerman gave a presentation on the new D10 Community Market, which was born out of legislation created by Supervisor Ahsha Safai and Geoffrea Morris in 2021 under ordinance 102-21. It is a market that aims to allow shoppers to exercise the right to choose what they bring home to eat by providing fresh produce and healthy options in D10. Client eligibility: They must live in D10, must have children in the home, and clients must be on some government or other support service: CalFresh, Medi-Cal, WIC, SSI, CalWORKS, Produce Vouchers, etc. The D10 Market is currently serving about 600 families per month. Families are coming in once per month. The D10 Community Market is funded by HSA through Bayview Senior Services. There are volunteer | None. |
