Kaylene Buteau, MS has been a health and fitness professional for 35 years. 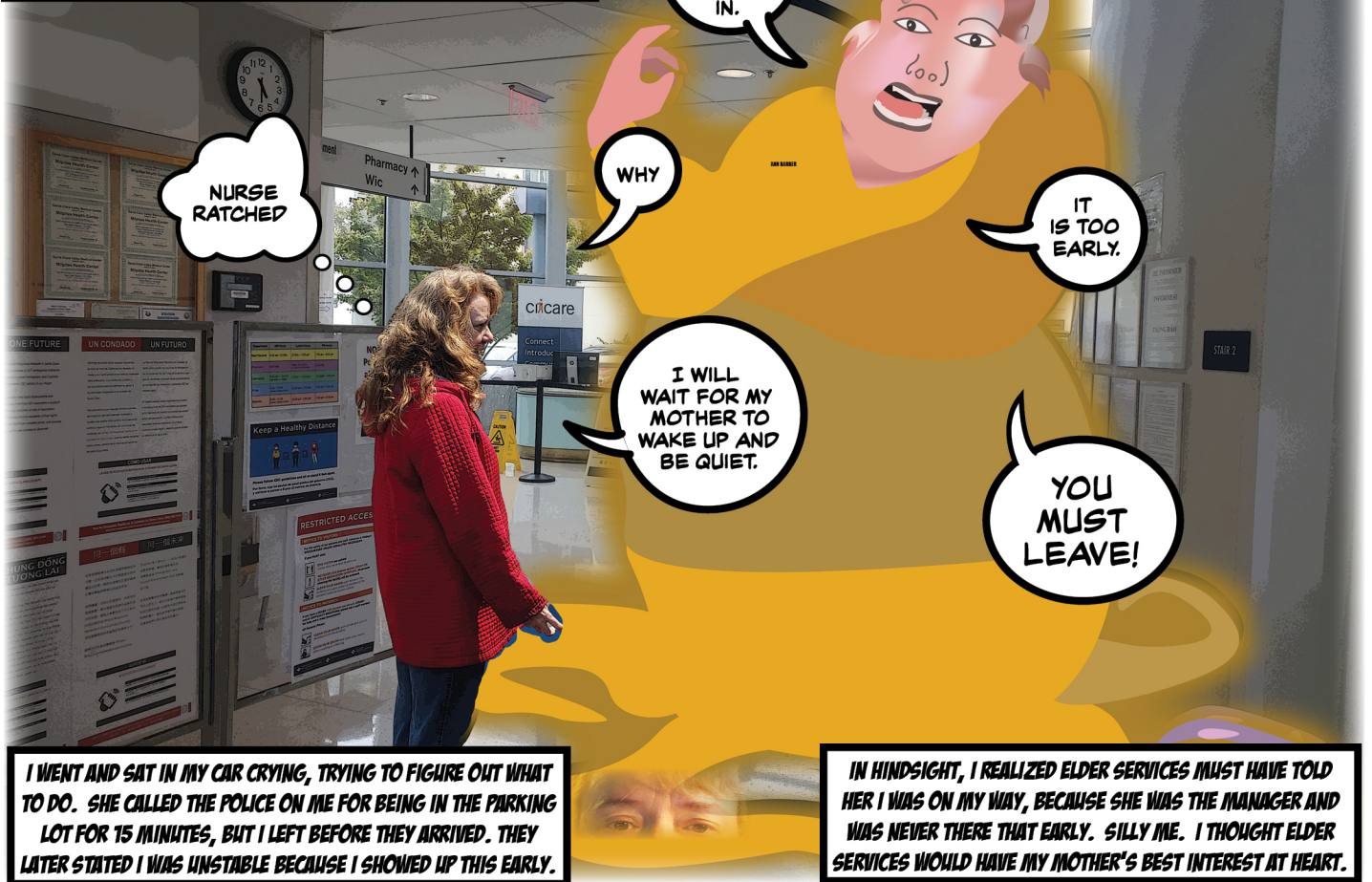

IT IS TOO EARLY.

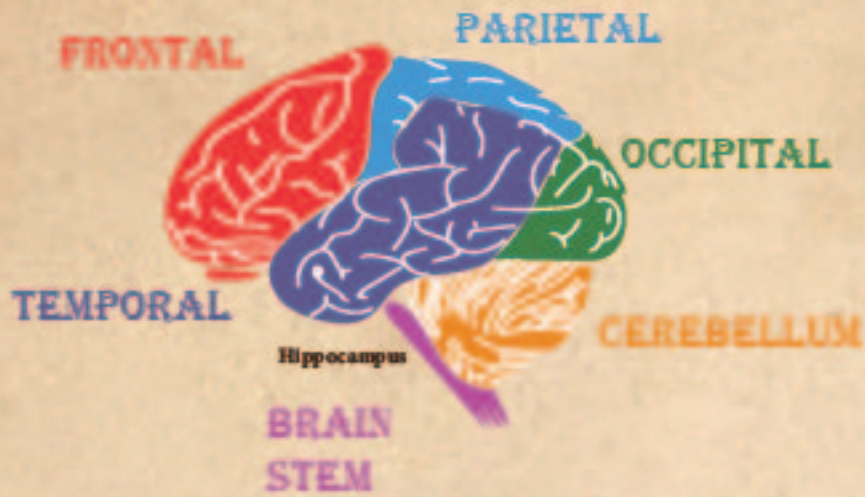
I WILL WAIT FOR MY MOTHER TO WAKE UP AND BE QUIET.

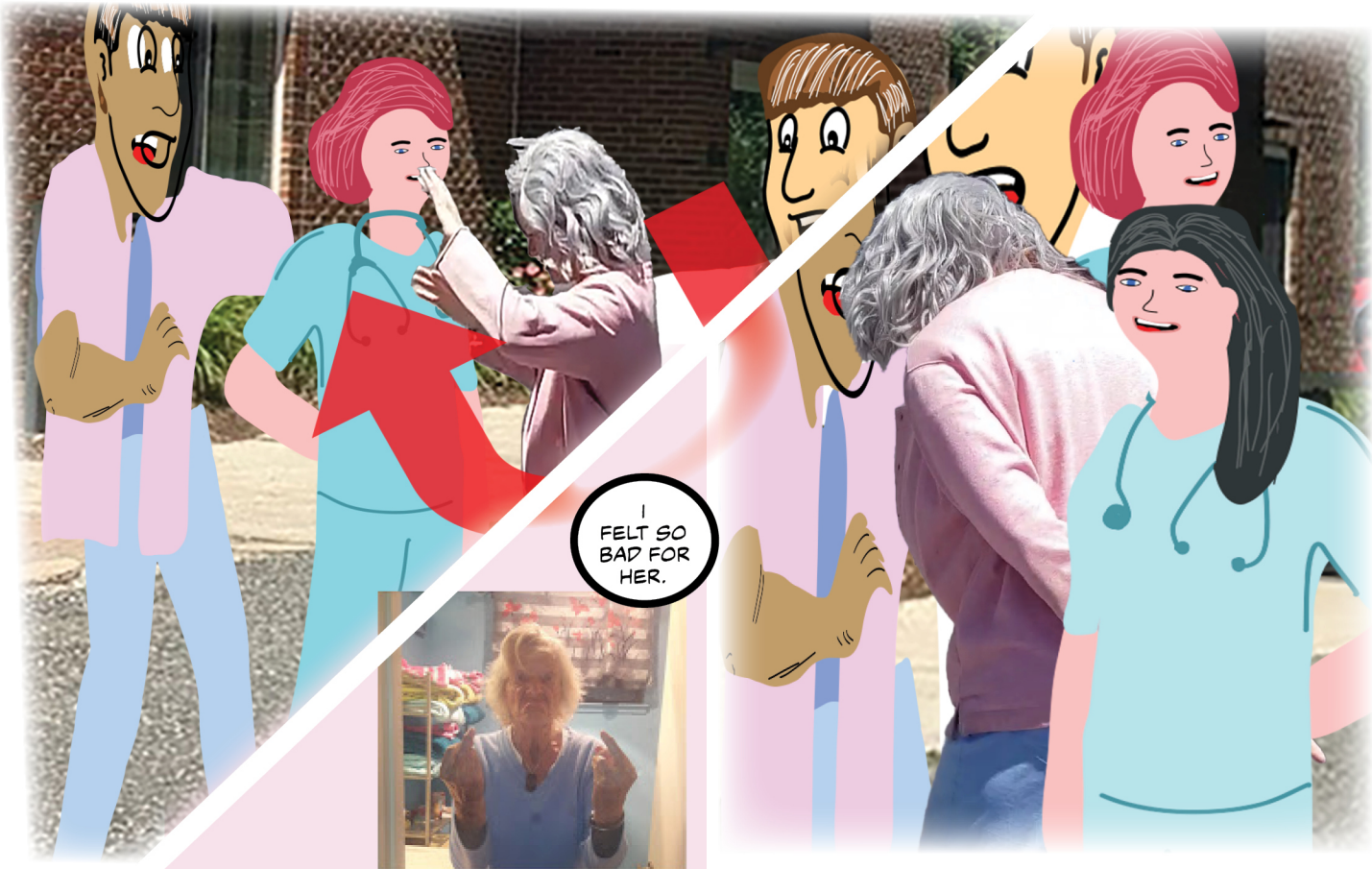


DEMENTIA ROAD MAP
