I am a caricature artist who draw portraits in which the subjects' features are exaggerated in a hilarious way.

I plan to sell hand-drew cartoon portraits, aka caricatures in which I catch my customers appearance and spirit in a funny and speedy way. It usually takes 20 minutes per person for colored picture. I use markers to outline the structure and color it with pastel. I can draw live caricature or drawings based on photos. I use equipments including easel, wood drawing board, standing lamp.

My handcrafted caricatures stand out through storytelling inspired by my customers. I like to capture their unique personality by drawing different facial expressions and body movements captured from their natural interactions with me. I use high quality materials including copic markers produced in Japan, which is well known for its brush flexibility to create energy and capture personality through wide or slim lines, and neocolor pastel produced in Netherlands, which is highly saturated to really enhance the happy and joyful feelings, making each piece of my drawings a unique storytelling artwork.

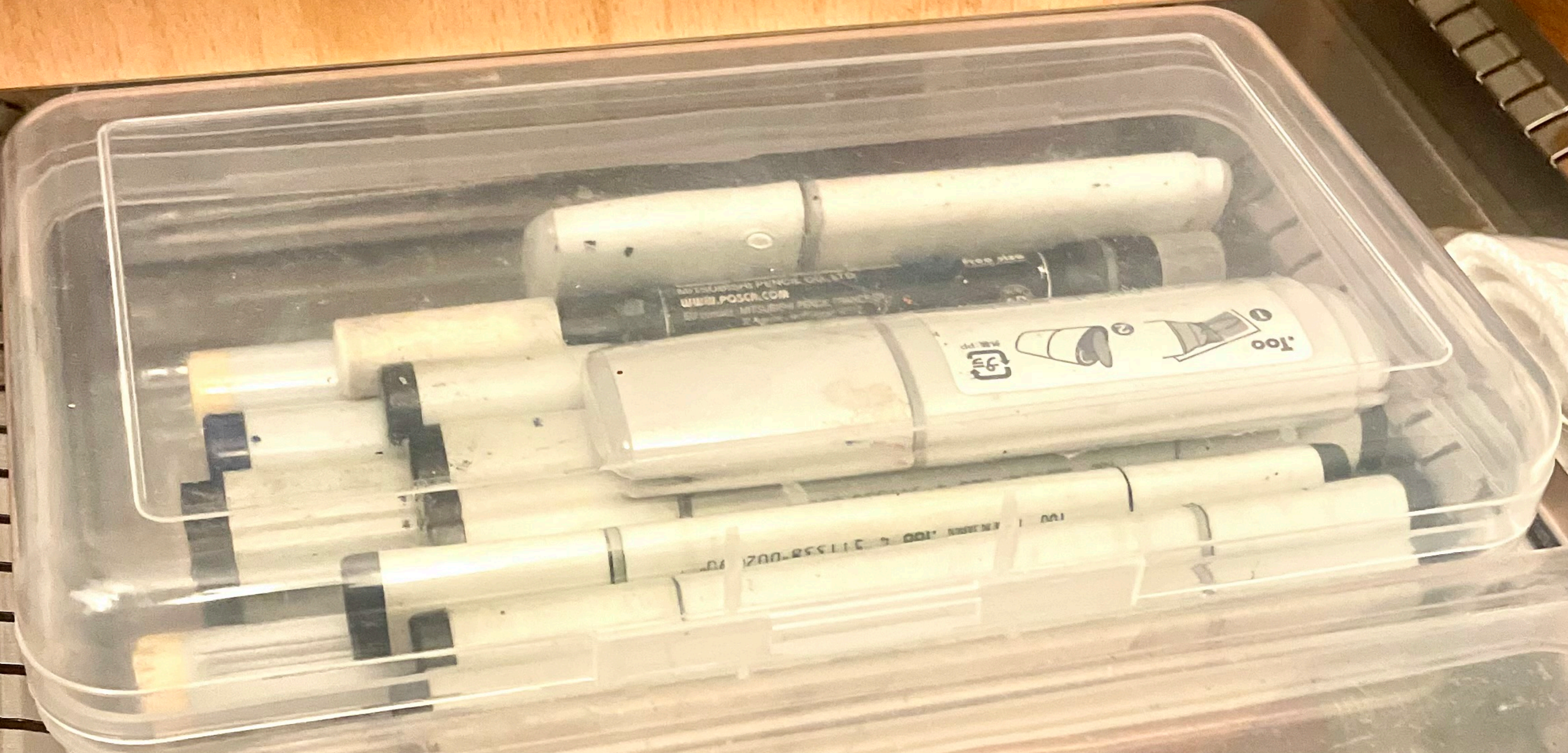
