**With a decade of experience behind the lens, Bay View Media (BVM) is a photographer and videographer whose work spans the diverse landscapes of the United States and beyond. Specializing in street and landscape photography, [he/she/they] captures the raw authenticity of urban life alongside the breathtaking majesty of natural environments. BVM's versatile approach encompasses aerial, digital, and film photography, allowing for a rich variety of perspectives and textures. From the intimate grain of analog film to the crisp precision of digital capture and the sweeping vistas achieved through aerial work, each medium serves as a distinct tool for visual storytelling. BVM has sold prints in shows throughout the Bay Area, including Santa Cruz, San Francisco, San Mateo, and Berkeley. In-person shows provide a chance for the general public to purchase prints for their homes, living spaces, work, and gifts for others. These unique and high-quality prints often serve as reminders of places patrons have been or inspire dreams of where they wish to go next. **I plan to sell photographic prints of images I have personally captured during my travels across the United States and internationally. My collection primarily features photographs from California, Japan, and Mexico, with additional work from locations like New York City, Hawaii, and Vancouver. The prints will be available in two main size options to accommodate different buyer preferences and price points. Customers can choose between framed or unframed prints, allowing flexibility based on their display needs and budget. After I capture the images in digital, film, or aerial settings, I then color grade them in Lightroom. I then print them on a professional grade printer, and package them in my home studio**

**I received my first camera when I was 18 and have been drawn to the lenses of photography and videography ever since. I've never taken a formal class but have learned from a community of friends on the east coast, many of whom are professional photographers. My work also appeals to a high percentage of California residents as a lot of my portfolio is from California, Mexico, and Japan. I also ensure reasonable pricing so people of all economic backgrounds can own high quality pieces of art. Finally, given I control my entire print process, the prints are limited in number (many of them are not posted online so the only time my audience can purchase is in person).**

I also limit the promotion of my work online out of concern it may be taken for an unauthorized reproduction by humans or AI. Almost every photo is also labeled with my Trademark.**

**I've researched the relevant laws around my photography business. Most of my work is landscape photography which has minimal IP issues associated with it. My other work is street photography, which undergoes an internal review to ensure no issues are present. 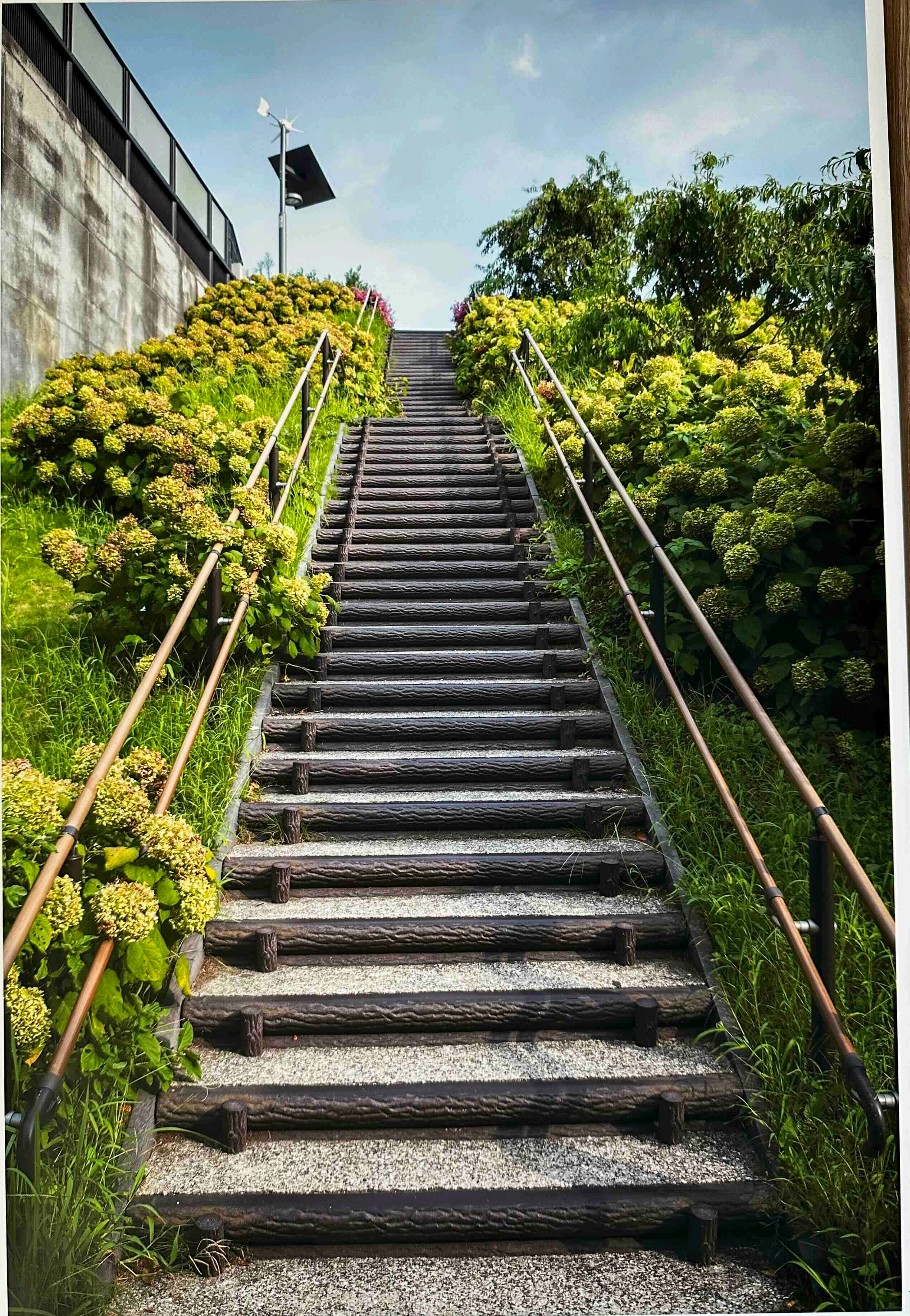
14. Describe the safety procedures you use in your craft. What, if any, safety equipment do you use? How do you store and handle any toxic or hazardous material?

**I have minimal safety concerns with my business. The ink used to make the images are non-toxic dye based ink tanks. Most other materials (packaging materials) are made of paper, cardboard and wood. I generally do not handle toxic chemicals. When selling in person, I always ensure safety features like sand bags on the legs of the tent to reduce the likelihood of any issues. I also carry drone and event insurance should anything go wrong.**
