# SF BHSA Community Program Planning (CPP) in 2025

- **SF Behavioral Health Services (BHS) team held 12 CPP meetings in 2025.**
  - Meetings included: community groups (service providers and consumers), the SF BHSA Advisory Committee, the SF BHS Client Council, and the SF BH Commission.
- **BHS also conducted targeted outreach to BHSA stakeholders.**
