Performance Measure	Target
In-house building permit issuance time	Steady improvement
Over-the-counter building permit issuance time	Hold at median of 1 calendar day
Completeness letters issued in 21 calendar days or less	75%
First comments issued in 30 calendar days or less	75%
Responses to revisions issued in 14 calendar days or less	75%

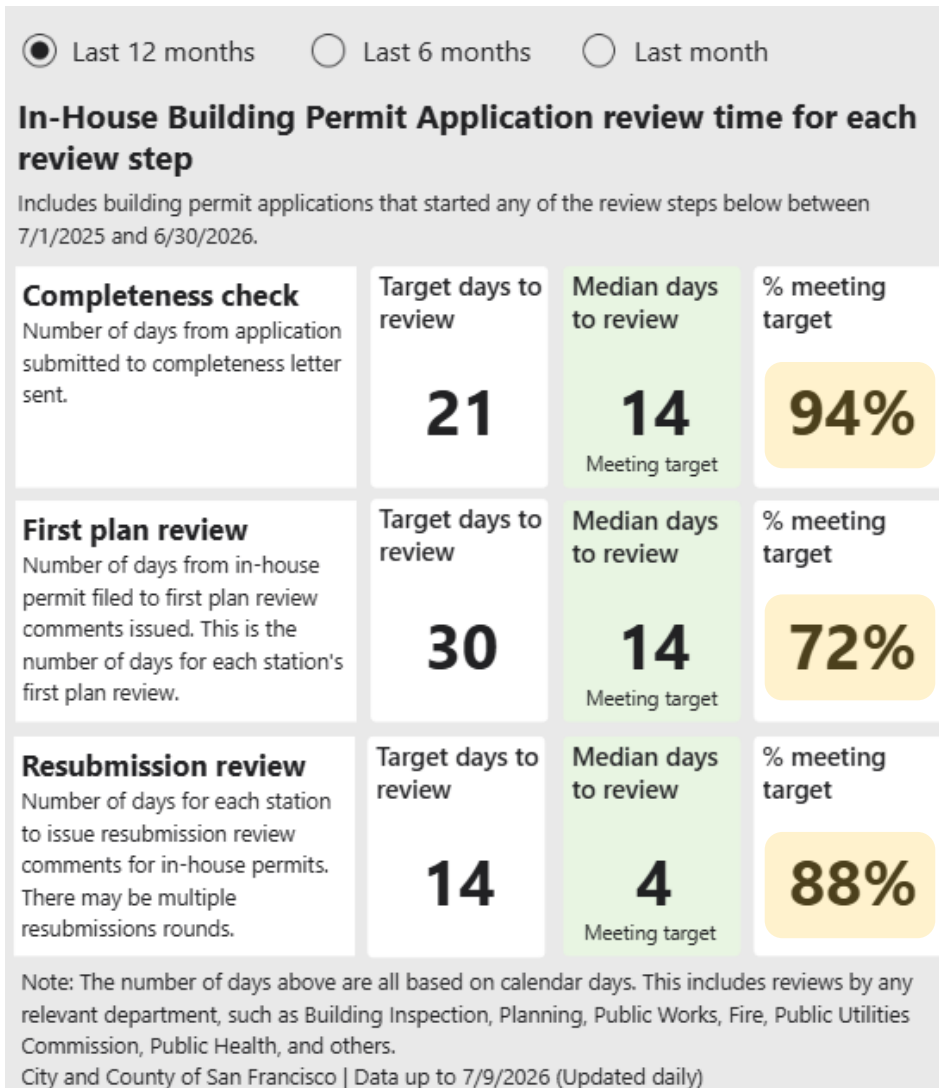

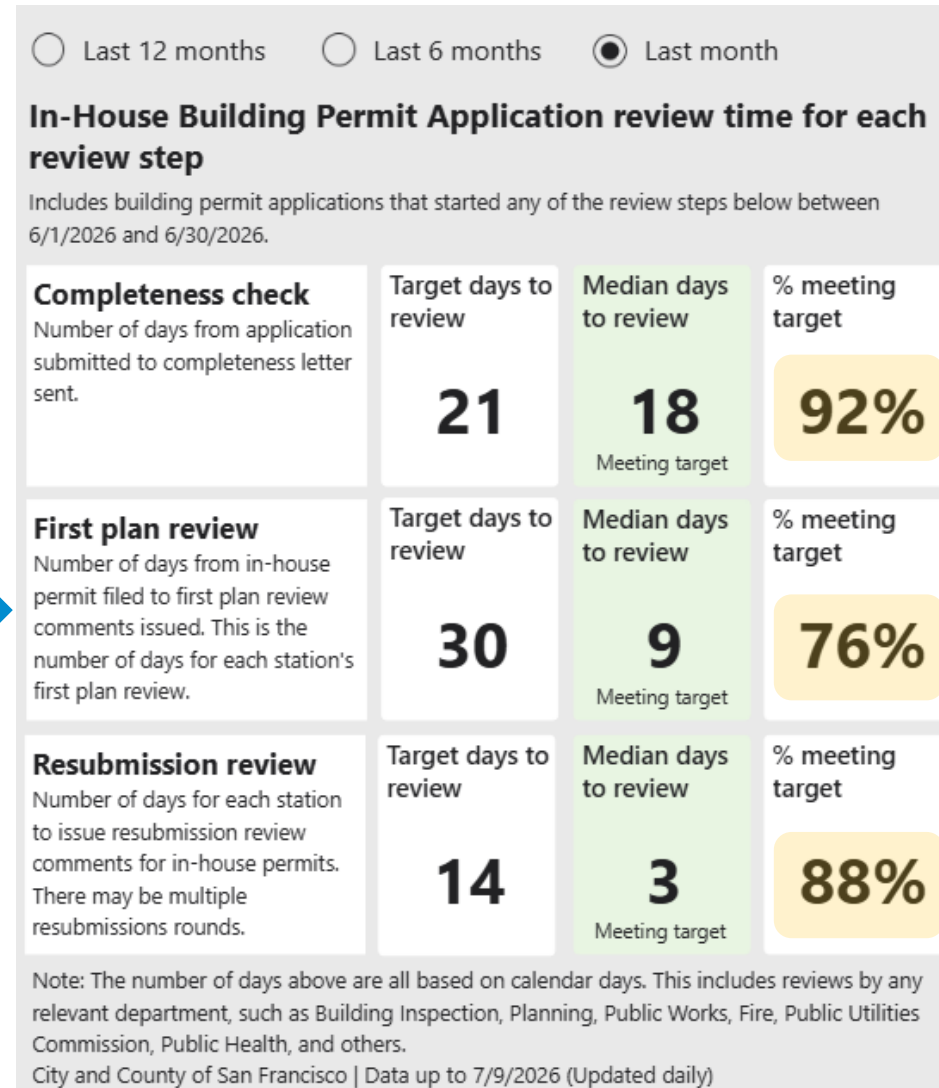

As of July 9, more than 1,300 building permit applications had been submitted through the OpenGov PermitSF Portal. This now includes permits for doors, windows, and siding; reroofing; and signs and awnings. 54% had received their permit, and the median days to issue the permit has held steady at 3 business days.
