(1) PUBLIC COMMENT

At this time, members of the public may address the Board on items of interest to the public that are within the subject matter jurisdiction of the Board except agenda items. With respect to agenda items, your opportunity to address the Board will be afforded when the item is reached in the meeting with one exception. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Board has closed the public hearing, your opportunity to address the Board must be exercised during the Public Comment portion of the calendar. Each member of the public may address the Board for up to three minutes. At the discretion of the Board President, public comment and remote public participation may be limited to two minutes per person. If it is demonstrated that public comment and remote public participation will cumulatively exceed 15 minutes, the President may continue Public Comment and/or remote public participation to another time during the meeting.

SPEAKERS: John Nulty spoke about the reports submitted by the Bureau of Urban Forestry ("BUF"), which provided updates on two appeals previously heard by the Board. The previous appeals involved the removal of trees at 401 Parnassus Avenue and 198 McAllister Street. Mr. Nulty indicated that it was not clear from the reports for both cases where some of the trees were going to be replanted. He noted that for the 401 Parnassus Avenue case, 105 trees were supposed to be planted in Potrero Hill, but the map submitted by BUF showed them being planted all over the City. Mr. Nulty further indicated that the fact that the trees had still not been planted years after these cases had concluded showed how slow BUF was in getting things done.

(2) **COMMISSIONER COMMENTS & QUESTIONS**

SPEAKERS: President Trasviña welcomed everyone to the meeting. He referenced the two cases identified by Mr. Nulty during Public Comment and stated that he wanted to invite the department and interested members of the public to a future hearing so that questions and concerns about the reports could be addressed.

Appealing the DENIAL on February 4, 2025, of a Retail Tobacco Sales Permit (application for a Retail Tobacco Sales Permit has been denied for the following reasons: (1) no new permit shall be issued in any supervisorial district that has 45 or more Establishments with Tobacco Sales Permits, the business location is in Supervisorial District 6 which currently has 77 valid Retail Tobacco Sales Permits, (2) no new permit shall be issued if the applicant will be located within 500 feet of an existing Establishment; the business location is located within 500 feet of one other Establishment that has a Retail Tobacco Sales Permit, (3) no new permit shall be issued to any applicant whose main purpose is offering food or alcoholic beverages for sale or consumption on the premises, the business location is permitted as a Bar & Tavern).
