(4) REHEARING REQUEST FOR APPEAL NO. 24-066

Subject property at 695 Rhode Island Street. Dan Feldman, Appellant, is requesting a rehearing of Appeal No. 24-066, DAN FELDMAN vs. DEPT. OF BUILDING INSPECTION, PLANNING DEPT. APPROVAL, decided May 21, 2025. At that time, upon motion by Commissioner Swig, the Board voted 5-0 to deny the appeal and uphold the permit on the basis that the Variance Decision approved under Appeal No. 25-016 makes the permit Code compliant. **Permit Holder:** Charles Quach. **Permit Description:** remodel of an existing two-story, two-unit residence; scope of work to include new rear horizontal extension at existing lower level, first and second floor, and new vertical addition of third floor; façade alterations including a new garage door, driveway and curb cut. **Permit No.:** 2019/12/20/0232.

ACTION: Upon motion by President Trasviña, the Board voted 4-0-1 (Commissioner Saroyan absent) to deny the request on the basis that the new evidence would not have changed the outcome of the original hearing.

807 44th Avenue.

Appealing the CANCELLATION on April 17, 2025, of an Alteration Permit (The permit has been cancelled by the Planning Department for the following reason: the revised scope that proposes an internal connection between the Unauthorized Dwelling Unit (UDU) and primary unit is considered a Residential Merger and requires a Conditional Use Authorization (CUA) to be granted by the Planning Commission; to date, the applicant has not submitted a CUA for a Residential Merger and has stated they will not revise the plans to remove the interior connection between the units: Permit Description: Legalize Accessory Dwelling Unit (ADU) one bedroom, one bathroom on the first floor; comply with NOV No. 202183025). PERMIT NO. 2023/09/22/7235.

ACTION: Upon motion by Commissioner Lopez, the Board voted 4-0-1 (Commissioner Saroyan absent) to deny the appeal and uphold the cancellation of the permit on the basis that it is consistent with the Code.
