# REGULAR MEETING (IN-PERSON AND REMOTE ACCESS VIA ZOOM)

#### (1) PUBLIC COMMENT

With respect to agenda items, your opportunity to address the Board will be afforded when the item is reached in the meeting with one exception. When the agenda item has already been reviewed in a public hearing at which members of the public were allowed to testify and the Board has closed the public hearing, your opportunity to address the Board must be exercised during the Public Comment portion of the calendar. Each member of the public may address the Board for up to three minutes. At the discretion of the Board President, public comment and remote public participation may be limited to two minutes per person. If it is demonstrated that public comment and remote public participation will cumulatively exceed 15 minutes, the President may continue Public Comment and/or remote public participation to another time during the meeting.

SPEAKERS: Georgia Schuttish spoke about how AB 1114 limits the right to appeal to the Board. She stated that she thought the Board should hold another informational hearing on this Bill after Labor Day. She further suggested that Board Members provide feedback to Planning Director Hillis and his staff on the objective design standards that are now being developed.

#### (4) JURISDICTION REQUEST NO. JR-24-5

**Subject property at 551 Alvarado Street.** Letter from Catherine Woods, requestor, asking that the Board take jurisdiction over Street Improvement Permit No. 23IE-00435, which was issued on July 17, 2024. The appeal period ended on August 1, 2024, and the jurisdiction request was filed at the Board office on August 8, 2024. **Permit Holder**: Randall Laroche . **Permit Description**: Remove and reconstruct new ten-foot driveway curb cut and sidewalk per approved plan, saw-cut two-feet of AC gutter and replace with two inches ACWS over eight-inch concrete base; additional paving as required and directed by SFPW/BSM inspector; field inspection is mandatory prior to excavation and pouring concrete.

ACTION: Upon motion by Vice President Lemberg (Levy), the Board voted 5-0 to grant the request on the basis that the City inadvertently caused the requestor to be late in filing the appeal because Public Works's website was not updated to show that the permit was issued.

3310 MISSION STREET OWNERS, Appellant(s)

DEPT. OF BUILDING INSPECTION, Respondent PLANNING DEPT. APPROVAL

3300 Mission Street.

Appealing the ISSUANCE on July 5, 2024, to 3300 Mission Partners L.P., of a Site Permit (Priority Processing: New 6-story, Type IIIA over Type 1A Mixed-Use Building with 35 studio units (100% Affordable Housing Mayor ED 13-01), residential community space and commercial/retail space on first floor; preserve existing 3-story facade along Mission Street and 29th Street). PERMIT NO. 2023/10/25/9516.
