**A. BLACK WOMEN REVOLT AGAINST DOMESTIC VIOLENCE (BWRADV)**

**DISCUSSION and possible ACTION**

Pursuant to Administrative Code Section 21G.8, the Commission will discuss and possibly adopt a resolution approving an amendment to a grant agreement with Black Women Revolt Against Domestic Violence (BWRADV), fiscally sponsored by San Francisco Study Center, increasing the grant amount by an additional \$160,000 using funds received from the San Francisco Human Rights Commission, in order to further expand BWRADV's capacity to deliver culturally responsive and trauma informed services to Black survivors of domestic violence.
