

Resolution Approving the Juvenile Probation Department's Retroactive Request to Waive of Solicitation Requirements to Issue Sole Source Grants to Welcome Home Oasis, and Restorative Academic Mentorship Program (RAMP), for Less Restrictive Programs and Reentry Housing and Support Services

BE IT KNOWN that the Juvenile Probation Department of the City and County of San Francisco hereby issues and authorizes the execution, by the subscribing Commissioners, of the following commendation:

WHEREAS, Chapter 21G of the Administrative Code ("Chapter 21G") governs the award of grants and provides that granting agencies shall award all grants through an open and competitive process; and

WHEREAS, Pursuant to Section 21G.8 of the Administrative Code the Juvenile Probation Commission ("Commission") may approve a waiver of the open and competitive process required under Chapter 21G if (1) a competitive process is infeasible or impracticable or (2) the Public Purpose may reasonably be accomplished by one particular Grantee; and

WHEREAS, pursuant to SB 823 & 92 and WIC 875, the Department must provide less restrictive program opportunities to young people committed to a term of confinement at the Juvenile Justice Center ("SYTF Youth"); and

WHEREAS, on September 10, 2025, in accordance with Section 21G.8 of the Administrative Code, the Commission approved the issuance of two sole source grants to the following grantees: (1) Welcome Home Oasis and (2) Restorative Academic Mentorship Program (RAMP), for court-ordered reentry housing and support services, with the original agreements allowing for both program delivery and associated operational costs necessary to implement these services effectively; and

WHEREAS, the anticipated term for the grant for Welcome Home Oasis will be 12 months in the amount of \$150,000; and

WHEREAS, the anticipated term for the grant for Restorative Academic Mentorship Program (RAMP) will be 12 months in the amount of \$150,000; and

WHEREAS, Welcome Home Oasis and Restorative Academic Mentorship Program (RAMP) were identified by the California Office of Youth and Community Restoration (OYCR) as Less Restrictive Programs currently serving Los Angeles County Youth and were further identified by local Los Angeles County providers and the San Francisco Juvenile Probation Department as having appropriate and sufficient residential and staffing models to support young people exiting long-term secure commitments; and

WHEREAS, the purpose of each grant is to provide youth exiting secure commitment at the Juvenile Justice Center, as ordered by the court, with highly structured, less restrictive transitional housing programs with other supports; and

WHEREAS, the services will benefit both the youth and the public by investing in long-term community-based reentry solutions, which aligns with the Department's objectives relating to public safety and youth rehabilitation; and

NOW THEREFORE BE IT RESOLVED that the Juvenile Probation Commission finds that the original justification for the sole source grants continues to exist and seeking a new grantee would disrupt and delay the provision of services and therefore hereby approves the grants for Welcome Home Oasis and Restorative Academic Mentorship Program (RAMP).
