Agency	Description
Help Desk	Don't know where to start? Come visit us at the help desk and we'll point you in the right direction!
SF City Partner Support Team	The SF City Partner Support team at the Controller's Office manages the City's supplier portal. Visit this table for: portal navigation, questions about where to register as a City bidder or supplier, account issues.
CON - Supplier Management Team	The Controller's Office - Supplier Management Team (CON SMT) helps businesses navigate the bidder and supplier registration processes. Visit this table for: help with creating an account, process steps to become a bidder or supplier, account management.
TTX - Tax Payer Assistance Unit	The Taxpayer Assistance Unit at the Office of the Treasurer & Tax Collector (TTX) oversees all business registrations in San Francisco. Visit this table for: questions about whether your business needs to be registered in San Francisco, and help with connecting your Business Account Number (Business Registration Certificate #) to your City supplier ID.
TTX - SF Lends	The Office of the Treasurer & Tax Collector (TTX) administers SF Lends, a program that can help point your business to financial resources and access to capital. Visit this table to: learn more about financial resources available for small businesses.
Office of Labor Standards Enforcement (OLSE)	The Office of Labor Standards Enforcement (OLSE) oversees compliance with the City's labor laws including the Health Care Accountability Ordinance (HCAO) and the Minimum Compensation Ordinance (MCO). These two ordinances are part of the supplier registration process. Visit this table to: learn about HCAO and MCO compliance requirements for your business.
CMD Equal Benefits Team	The Equal Benefits Team at the Contract Monitoring Division (CMD) manages the City's Equal Benefits Program. Compliance with this program is part of City contracting. Visit this table to: learn more about the Equal Benefits Program and compliance requirements for your business.

Agency	Description
CMD Certification Team	The Certification Team at the Contract Monitoring Division (CMD) manages the City's Local Business Enterprise (LBE) Program. Visit this table to: learn more about the LBE Program, eligibility criteria, and benefits of becoming certified.
CMD - Contractor Accelerated Payment Program	The Contract Monitoring Division (CMD) CAP Program connects San Francisco LBE contractors to loans for City projects. Visit this table to: learn more about eligibility for these project-based financing loans.
Department of Technology (DT) – Office of Cybersecurity	The Department of Technology (DT) is responsible for Cybersecurity Risk Assessment (CRA) and Chief Information Officer (CIO) review of technology purchases.
