

## BIRTH CERTIFICATE INSTRUCTIONS

## INSTRUCTIONS:

1. **ONLY** individuals who are authorized by Health and Safety Code Section 103526 can obtain a Certified Copy of a birth record to establish the identity of the registrant (person listed on the certificate). (Page 1 identifies the individuals who are authorized to make the request.) All others may receive a Certified Informational Copy, which will be marked, "Informational, Not a Valid Document to Establish Identity."

**Confidential Information on Birth Record:** Some individuals have special needs for a birth certificate that contains the confidential information provided at the time the birth record was prepared. This confidential information may be used to establish ethnicity, to provide health background, or for other personal reasons. For information on how to obtain a birth certificate containing the confidential information, please refer to the Birth Record section of the California Department of Public Health website at: [www.cdph.ca.gov](http://www.cdph.ca.gov). Only specific individuals may obtain confidential copies. Submit your request and fee directly to California Department of Public Health Vital Records - MS 5103, PO Box 997410 Sacramento, CA 95899-7410.

2. Complete a separate application for each birth record you are requesting.
3. Complete the **Applicant Information** section on Page 1 and provide your signature where indicated. In the **Birth Record Information** section, provide all the information you have available to identify the birth record. If the information you furnish is incomplete or inaccurate, we may not be able to locate the record.
4. **If the registrant has been adopted**, request the adopted name. If the registrant was born outside the United States and re-adopted in California, mark the "Yes" box and complete the application with the adopted information. (If you are requesting a copy of the original birth certificate, you must provide a court order releasing the original sealed record.) Submit your request and fee directly to California Department of Public Health Vital Records - MS 5103, PO Box 997410 Sacramento, CA 95899-7410.
5. **SWORN STATEMENT:**
  - The authorized individual requesting the certified copy must sign the attached Sworn Statement, declaring under penalty of perjury that they are eligible to receive the certified copy of the birth record and identify their relationship to the registrant – the relationship must be one of those identified on Page 1 of the application.
  - If the application is being submitted by mail, the Sworn Statement **must be** notarized by a US Notary Public. (To find a Notary Public, see your local yellow pages or call your banking institution.) **Please note:** Acknowledgements executed by Notaries Public outside of the USA are not accepted. Sworn Statements must be taken before an Ambassador, Minister, Consul, Vice Consul, or Consular Agent of the United States, or before any Judge of a Court of record having a seal in such foreign country. (CA CCP 2014) Law enforcement and local and state governmental agencies are exempt from the notary requirement.
  - You do not have to provide a Sworn Statement if you are requesting a Certified Informational Copy of the birth record.
6. **Submit \$31 for each copy** requested and a self-addressed prepaid stamped return envelope. If no record is found, the \$31 fee will be retained for searching for the record (as required by law), and a "Certificate of No Public Record" will be issued to the applicant. Indicate the number of copies you are requesting and include the correct fee(s) in the form of a personal check preprinted with the account holder's name from a U.S.A. issued bank, no foreign checks or international money orders. PLEASE SUBMIT CHECK OR MONEY ORDER – DO NOT SEND CASH (NOT RESPONSIBLE FOR FEES PAID IN CASH THAT ARE LOST, MISDIRECTED, OR UNDELIVERED). If you require return tracking or guaranteed delivery of your fulfilled order, you must provide a prepaid return air bill guaranteeing tracking and delivery, i.e., Federal Express, USPS Priority, UPS, or other. We are not responsible for non-delivery or non-receipt of fulfilled orders by your chosen return delivery method. Mail the completed application with the fee(s) and self-addressed prepaid stamped return envelope to the address below.
