RE: **Annual Report of Gifts Received in FY 2025-26**

As required by section 10.100-201 of the San Francisco Administrative Code and consistent with the policy and procedures for the acceptance of gifts adopted by the Health Commission in October 1995, this is the annual report of gifts received in FY 25-26.

During FY 25-26, DPH received approximately \$3M in gifts from 24 separate donors. The majority of the gifts were donations to Central, totaling approximately \$1.5M and including \$411K for an X-Ray machine for Primary Care patients. This donation was received as part of the Fiscal Year 2025-2026 Annual Appropriations Ordinance. Separate donations totaling approximately \$1.5M and \$2K were made to Zuckerberg San Francisco General Hospital and Laguna Honda Hospital, respectively. These donations included a mammography van and funding and in-kind donations that support the care, general benefit and comfort of patients.

Of the \$3M in gifts received, \$2,104,644 was reported to the Board of Supervisors through the accept and expend process.

Gifts received during FY 25-26 increased from the prior year due to the donation of funds for the purchase of an X-ray machine for the Primary Care clinics, in-kind donations of a mammography van from the San Francisco General Hospital Foundation, and COVID-19 test kits from the California Department of Public Health, which accounted for over \$2.4M of the approximately \$3M received during FY25-26.
